### A BILL FOR AN ACT

RELATING TO EMOTIONAL SUPPORT ANIMALS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 347-2.5, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§347-2.5 Service dog, defined. As used in this chapter,
- 4 "service dog" means any dog that is individually trained to do
- 5 work or perform tasks for the benefit of an individual [with]
- 6 who is certified in writing by a doctor to have a disability,
- 7 including a physical, sensory, intellectual, or other mental
- 8 disability[. A companion or comfort animal is not a service dog
- 9 unless it meets the requirements of this definition and it
- 10 accompanies a person for the purpose of performing the work or
- 11 tasks for which it has been trained.], including anxiety or any
- 12 other emotional disorder."
- 13 SECTION 2. Section 347-13, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "§347-13 Persons who are blind, visually handicapped,
- 16 disabled; public places; public conveyances. (a) Persons who
- 17 are blind, visually handicapped, or otherwise disabled are

- 1 entitled to full and equal accommodations, advantages,
- 2 facilities, and privileges of all common carriers, airplanes,
- 3 motor vehicles, railroad trains, motor buses, street cars,
- 4 boats, or any other public conveyances or modes of
- 5 transportation, hotels, lodging places, places of public
- 6 accommodation, amusement, or resort, and other places to which
- 7 the general public is invited, subject only to the conditions
- 8 and limitations established by law and applicable to all
- 9 persons.
- 10 (b) Every person who is blind, deaf, visually handicapped,
- 11 or otherwise disabled shall have the right to be accompanied by
- 12 a service animal, especially trained for the purpose of
- 13 assisting the person, or an emotional support animal, in any of
- 14 the places listed in subsection (a) without being required to
- 15 pay an extra charge for the service animal[+] or emotional
- 16 support; provided that the person shall be liable for any damage
- 17 done to the premises or facilities by the service animal [-] or
- 18 emotional support animal. No service animal or emotional
- 19 support animal shall be considered dangerous merely because it
- 20 is unmuzzled.

- 6 SECTION 5. This Act shall take effect upon its approval.
