#### A BILL FOR AN ACT

RELATING TO MAGNET SCHOOLS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there is a need to 2 create more educational opportunities for children in the public 3 school system. While recognizing the reforms to the educational 4 system brought about by the establishment of public charter 5 schools, the legislature also finds that there remains room for 6 further exploration of diverse methods of innovation in the 7 public schools. According to a report commissioned by Magnet 8 Schools of America and conducted by the University of North 9 Carolina-Charlotte's Urban Institute in 2016, there are 10 approximately 4,340 public elementary and secondary magnet 11 schools serving nearly 3.5 million students in the United 12 States.

13 The purpose of this Act is to authorize the department of 14 education to establish new magnet schools or convert existing 15 public schools to magnet schools.
