### A BILL FOR AN ACT

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 286-51, Hawaii Revised Statutes, is 2 amended by amending subsection (b) to read as follows: 3 This part shall be administered by the director of "(b) 4 finance in conjunction with the requirements of sections 249-1 5 to 249-13 and shall entail no additional expense or charge to 6 the person registering the ownership of a motor vehicle other 7 than as provided by this section or by other laws; provided that 8 for each new certificate of ownership issued by the director of 9 finance under section 286-52, the director of finance may charge 10 a fee which shall be deposited in the general fund. The fees 11 charged to issue a new certificate of ownership shall be 12 established by the county's legislative body. 13 Notwithstanding any other law to the contrary, an

14 additional fee of [not more than \$1 for each certificate of 15 registration for a U-drive motor vehicle and] \$2 for each 16 certificate of registration for all [other] motor vehicles may 17 be established by ordinance and collected annually by the

director of finance of each county, to be used and administered
 by each county:

3 (1) For the purpose of beautification and other related
4 activities of highways under the ownership, control,
5 and jurisdiction of each county; and

6 (2) To defray the additional cost in the disposition and other related activities of abandoned or derelict 7 vehicles as prescribed in chapter 290. For the 8 purposes of this paragraph, other related activities 9 10 shall include but need not be limited to any and all storage fees that are negotiated between each county 11 and a towing company contracted by the county to 12 13 remove and dispose of abandoned or derelict vehicles. 14 The \$2 fee established pursuant to this subsection for certificates of registration for all motor vehicles [other than 15 U-drive motor vehicles] may be increased by ordinance up to a 16 maximum of \$10; provided that all amounts received from any fee 17 increase over \$2 shall be expended only for the purposes of 18 paragraph (2).
