1	PART I. GENERAL PROVISIONS									
2	SECTION 1. The purpose of this Act is to establish the									
3	operating budget for the fiscal biennium beginning July 1, 2019,									
4	and ending June 30, 2021, for state executive branch programs									
5	under the purview of the department of accounting and general									
6	services.									
7	SECTION 2. Unless otherwise clear from the context, as									
8	used in this Act:									
9	"Expending agency" means the department of accounting and									
10	general services.									
11	Abbreviations, where used to denote the expending agency or									
12	a house of representatives standing committee, shall mean the

"Means of financing" or "MOF" means the source from which 1 funds are appropriated or authorized to be expended for the 2 programs and projects specified in this Act. All appropriations 3 are followed by letter symbols. The letter symbols, where used, 4 shall have the following meanings: 5 General funds 6 Α 7 В Special funds 8 Ν Federal funds Other federal funds 9 "Position ceiling" means the maximum number of permanent 10 and temporary full-time equivalent positions authorized for a 11 particular program during a specified period or periods, as 12 denoted by an asterisk for permanent full-time equivalent 13 positions and a pound sign for temporary full-time equivalent 14 15 positions.

"Program ID" means the unique identifier for the specific

program and consists of the abbreviation for the organization

responsible for carrying out the program followed by the

- 1 SECTION 3. The following sums, or so much thereof as may
- 2 be sufficient to accomplish the purposes and programs designated
- 3 herein, are hereby appropriated or authorized, as the case may
- 4 be, from the means of financing specified to the expending
- 5 agencies designated for the fiscal biennium beginning July 1,
- 6 2019, and ending June 30, 2021. The total expenditures and the
- 7 number of positions in each fiscal year of the biennium shall
- 8 not exceed the sums and the position ceilings indicated for each
- 9 fiscal year, except as provided elsewhere in this Act or as
- 10 provided by general law.

1	PART	III.	MISCELLANEOUS	AND	EFFECTIVE	DATE

- 2 SECTION 4. If any portion of this Act or its application
- 3 to any person, entity, or circumstance is held to be invalid for
- 4 any reason, then the legislature declares that the remainder of
- 5 the Act and each and every other provision thereof shall not be
- 6 affected thereby. If any portion of a specific appropriation is
- 7 held to be invalid for any reason, the remaining portion shall
- 8 be expended to fulfill the objective of the appropriation to the
- 9 extent possible.
- 10 SECTION 5. If manifest clerical, typographical, or other
- 11 mechanical errors are found in this Act, the governor may
- 12 correct the errors.
- SECTION 6. This Act shall take effect on July 1, 2019.
