A BILL FOR AN ACT

RELATING TO THE GENERAL EXCISE TAX.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 237-24.9, Hawaii Revised Statutes, is 1 2 amended by amending subsection (b) to read as follows: "(b) As used in this section: 3 "Aircraft" means any [craft]: Craft or artificial contrivance of whatever 5 (1) description engaged in intrastate, interstate, or 6 international scheduled commercial use as defined in 7 chapter 263, that operates with two or more jet 8 engines[-]; or 10 (2) Helicopter. "Aircraft service and maintenance" means all scheduled and 11 unscheduled tasks performed within an aircraft service and 12 13 maintenance facility for the inspection, modification, maintenance, and repair of aircraft and related components 14 including engines, hydraulic and electrical systems, and all 15

other components which are an integral part of an aircraft.

19	"Maintenance" means the upkeep of aircraft engines,
20	hydraulic and electrical systems, and all other components which
21	are an integral part of an aircraft, but does not include

- 1 refueling, janitorial services or cleaning, restocking of
- 2 aircraft and passenger supplies, or loading or unloading of
- 3 cargo and passenger baggage."
- 4 SECTION 2. Statutory material to be repealed is bracketed
- 5 and stricken. New statutory material is underscored.
- 6 SECTION 3. This Act shall take effect upon its approval
- 7 and shall be repealed on December 31, 2023; provided that
- 8 section 237-24.9(b), Hawaii Revised Statutes, shall be reenacted
- 9 in the form in which it read on the day prior to the effective
- 10 date of this Act.

Report Title:

General Excise Tax; Helicopters; Service and Maintenance Facility; Quiet Technology; Exemption; Sunset

Description:

Establishes a five-year general excise tax exemption for amounts received from the servicing and maintenance of helicopters in an aircraft service and maintenance facility or from the construction of a facility that services and maintains helicopters; provided that 75% of the helicopters serviced and maintained annually in the facility are equipped with quiet technology. Sunsets 12/31/2023.
