No member of the task force shall be made subject to 7 8 section 84-17, Hawaii Revised Statutes, solely because of that 9 member's participation on the task force. 10 The task force shall convene no later than thirty days (d) after the effective date of this Act. 11 12 The task force shall serve until it has accomplished (e) 13 the objectives of this Act or twenty days prior to the convening 14 of the regular session of 2020, whichever occurs first. 15 SECTION 4. This Act shall take effect on July 1, 2050.
