### A BILL FOR AN ACT

RELATING TO FISHING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 187A, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§187A- Near shore fishing tour guides; license;
5	restricted areas. (a) The department shall issue to any
6	qualified person a near shore fishing tour guide license.
7	(b) The license shall be valid in any county; provided the
8	license shall not be valid for near shore fishing tour guide
9	service at any marine preserve, marine sanctuary, or prohibited
10	fishing areas under sections 188-34, 188-35, and 188-36.
11	(c) The cost of the license shall be three per cent of the
12	monthly gross revenues earned by the near shore fishing tour
13	guide or \$200 per month, whichever is more.
14	(d) Near shore fishing tour guides shall:
15	(1) Be exempt from a commercial use permit for state boat
16	launching ramps required by the department of land and
17	natural resources; provided that the near shore

1		fishing tour guide possesses a valid near shore
2		fishing tour guide license and the near shore fishing
3		tour guide's gross revenues do not exceed \$250,000 per
4		boat per year;
5	(2)	Possess a valid captain's license, in accordance with
6		United States Coast Guard regulations, if the guided
7		activity involves use of a motorized vessel; provided
8		that if the guided activity is onshore, no captain's
9		license shall be required;
10	(3)	Have access to beaches, oceans, and shorelines and
11		shall be exempt from obtaining written permission from
12		a county or other entity to access those areas;
13	(4)	Have basic first aid and cardiopulmonary resuscitation
14		certification; and
15	(5)	Possess general liability and commercial boat
16		insurance.
17	<u>(e)</u>	The department may adopt rules pursuant to chapter 91,
18	to implem	ent this section, including establishing the license
19	requireme	nts, restricted areas, and terms and conditions of the
20	near shor	e fishing tour guide license.

1	As used in this section, unless the context clearly
2	indicates otherwise:
3	"Bait casting fishing" means a rod, reel, line, and hook
4	used by fishers to catch fish on a reel that has a revolving
5	spool and sits on top of a casting rod.
6	"Light tackle fishing" means a rod, reel, line, and hook
7	used by fishers to catch fish on a line class strength of twenty
8	pounds or lighter.
9	"Near shore fishing tour guide" means any person who for
10	compensation acts as a guide to persons engaged in fly fishing,
11	light tackle fishing, or bait casting fishing within state
12	marine waters as defined in section 187A-1.5 or within three
13	miles from the shoreline, whichever is closer."
14	SECTION 2. This Act does not affect rights and duties that
15	matured, penalties that were incurred, and proceedings that were
16	begun before its effective date.
17	SECTION 3. New statutory material is underscored.
18	SECTION 4. This Act shall take effect upon its approval.
