BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1 | SECTION 1. The legislature finds that the state building |

| 16 | which requires stakeholders to meet and discuss the various |

- 2 counties and for designers and contractors.
- 3 The purpose of this Act is to repeal the requirement for
- 4 the state building code to be adopted after public hearings
- 5 pursuant to chapter 91, Hawaii Revised Statutes, and to instead
- 6 only require the code to be adopted pursuant to chapter 92,
- 7 Hawaii Revised Statutes, to be in conformance with all the other
- 8 state buildings codes.
- 9 SECTION 2. Section 107-29, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- "[+] §107-29[+] Rules. The department [shall] may adopt
- 12 rules pursuant to chapter 91 necessary for the purposes of this
- 13 part."
- 14 SECTION 3. Statutory material to be repealed is bracketed
- 15 and stricken. New statutory material is underscored.
- 16 SECTION 4. This Act shall take effect upon its approval.
