### A BILL FOR AN ACT

RELATING TO BROADBAND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Hawaii Revised Statutes is amended by
2	adding a new chapter to be appropriately designated and to read
3	as follows:
4	"CHAPTER
5	HAWAII BROADBAND OFFICE
6	<b>§ -1 Definitions.</b> As used in this chapter:
7	"Broadband" means high-speed internet access that is always
8	on, including mobile and fixed technologies.
9	"Office" means the Hawaii broadband office.
10	§ -2 Hawaii broadband office; establishment; state
11	broadband strategy officer; staff. (a) There is established
12	the Hawaii broadband office within the department of business,
13	economic development, and tourism.
14	(b) The director of business, economic development, and
15	tourism shall appoint, exempt from chapter 76, a state broadband
16	strategy officer to head the office. The department shall
17	employ any staff as may be necessary for the purposes of this



1	chapter; ]	provided that any staff employed pursuant to this
2	section s	hall be exempt from chapter 76.
3	§	-3 Hawaii broadband office; duties. In furtherance of
4	the State	's objectives and policies for the economy pursuant to
5	section 2	26-10.5, the office shall:
6	(1)	Develop and implement specific strategies and plans to
7		aggressively increase broadband affordability,
8		penetration, and competitive availability in the
9		State;
10	(2)	Support the efforts of both public and private
11		entities in Hawaii to enhance or facilitate the
12		deployment of and access to competitively priced,
13		advanced electronic communications services, including
14		broadband and its products and services and internet
15		access services of general application throughout
16		Hawaii;
17	(3)	Promote the landing of trans-Pacific submarine cable,
18		including the development of a shared access cable
19		station and associated terrestrial connectivity to
20		reduce barriers to fiber landing in Hawaii;



1		(4)	Promote, advocate, and facilitate the implementation
2			of the findings and recommendations of the Hawaii
3			broadband task force established by Act 2, First
4			Special Session Laws of Hawaii 2007; and
5		(5)	Actively seek out funding from private and public
6			sources in furtherance of the office's duties pursuant
7			to this chapter.
8		S	-4 Broadband planning and coordination; cooperation.
9	(a)	The	office shall:
10		(1)	Seek input and the widest possible cooperation from
11			public and private agencies and individuals to achieve
12			the purposes of this chapter;
13		(2)	Work closely with and assist the counties in the
14			promotion of coordinated state and county broadband
15			planning; and
16		(3)	Encourage every state department, county agency, and
17			other public or private agencies and individuals
18			involved in broadband programs to participate in the
19			activities of the office and incorporate, to the
20			extent feasible, the ideas and suggestions of the

participants in the office's comprehensive planning
 goals.

3 (b) The executive heads of all state departments and
4 agencies shall cooperate with the office by providing any
5 information deemed necessary by the governor and the director of
6 business, economic development, and tourism for the effective
7 discharge of the office's duties.

8 (c) Nothing in this chapter shall be construed to delegate
9 or detract in any way from the functions, powers, and duties
10 conferred by law or rule on any department or agency of the
11 State or county."

SECTION 2. Act 199, Session Laws of Hawaii 2010, as amended by section 5, Act 151, Session Laws of Hawaii 2011, as amended by section 2, Act 23, Session Laws of Hawaii 2016, is amended by amending section 3 to read as follows:

16 "SECTION 3. Telework promotion; broadband assistance
17 advisory council; establishment; purpose. (a) The director of
18 [commerce and consumer affairs] business, economic development,
19 and tourism, or the director's designee, shall convene and chair
20 the broadband assistance advisory council to advise the director
21 of [commerce and consumer affairs] business, economic

<u>development</u>, and tourism on policy and funding priorities to
 promote and encourage use of telework alternatives for public
 and private employees, and expedite deployment of affordable and
 accessible broadband services in Hawaii.

5 (b) The council shall be composed of the director of 6 commerce and consumer affairs, or the director's designee; the 7 director of business, economic development, and tourism, or the 8 director's designee; and the following twelve members who shall 9 be equally appointed by the president of the senate and by the 10 speaker of the house of representatives as follows:

11 (1) Two members of the senate, appointed by the president
12 of the senate;

13 (2) Two members of the house of representatives, appointed
14 by the speaker of the house of representatives;
15 (3) Four representatives of federal, state, and county
16 government entities having a role in infrastructure
17 deployment; management of public rights-of-way,

18 regulation, and franchising; information technology;19 and economic development; and

1 (4) Four representatives of Hawaii's private sector 2 technology, telecommunications, and investment 3 industries. 4 In making appointments pursuant to subsection (b)(1) through 5 (b)(3), the president of the senate and the speaker of the house 6 of representatives shall ensure representation of each of the 7 counties of Hawaii, Maui, and Kauai, and the city and county of 8 Honolulu by one or more appointed members. Except for the 9 director of commerce and consumer affairs and the director of 10 business, economic development, and tourism, all members shall 11 serve for a term of four years. Notwithstanding any law to the 12 contrary, the terms of all members as of July 1, 2016, shall 13 expire on June 30, 2019; and, each subsequent four-year term 14 shall commence on July 1, and expire on June 30 every four years 15 thereafter. Any member of the council whose term has expired 16 may continue to serve as a holdover member until reappointment 17 or until a successor is appointed. Any vacancies occurring in 18 the membership of the advisory council shall be filled for the 19 remainder of the unexpired term in the same manner as the 20 original appointments.

1 (C) The director of [commerce and consumer affairs] 2 business, economic development, and tourism, or the director's 3 designee, shall serve as chairperson of the council. The 4 chairperson may designate representatives of other interested 5 public or private sector organizations to serve as members of 6 the council, or as members of the work groups of the council to 7 address specified issues on an ad hoc basis, as the chairperson 8 deems necessary. The council shall meet at times as may be 9 called by the chairperson. Members and ad hoc members shall be 10 reimbursed for reasonable expenses, including travel expenses, 11 necessary for the performance of their duties. Administrative 12 support to the council shall be provided by the department of 13 [commerce and consumer affairs.] business, economic development, 14 and tourism. 15 (d) The council shall: 16 Monitor the broadband-based development efforts of (1)17 other states and nations in areas such as business, 18 education, and health; 19 (2) Advise the department on other states' best practices involving telework promotion and policies and

1	The sums appropriated shall be expended by the department
2	of business, economic development, and tourism for the purposes
3	of this Act.
4	SECTION 4. Statutory material to be repealed is bracketed
5	and stricken. New statutory material is underscored.
6	SECTION 5. This Act shall take effect on July 1, 2112.
