### A BILL FOR AN ACT

RELATING TO KEKAHA KAI STATE PARK.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that lifequards act as
- 2 the primary responders for emergencies on shorelines and within
- 3 nearshore waters, where the majority of ocean recreation
- 4 activity takes place. Lifequards also provide injury control
- 5 and dispatch ocean rescue services. Moreover, the legislature
- 6 also finds that although Kua Bay within Kekaha Kai state park in
- 7 North Kona on the island of Hawaii is under the jurisdiction of
- 8 the department of land and natural resources, the State
- 9 currently does not employ its own lifeguards at Kua Bay.
- 10 The legislature further finds that the location of Kua Bay
- 11 between Kona and the resorts of Kohala Coast and improvements to
- 12 Kekaha Kai state park, such as a paved road and comfort station,
- 13 have led to an increase in visits by locals and tourists, making
- 14 Kua Bay one of the most popular beaches in the State.
- 15 Consequently, the increase in visitation is accompanied by an
- 16 increase in dangerous incidents, injuries, and deaths, which
- 17 could be mitigated by placement of lifeguards at Kua Bay.



- 1 From 2013 to 2016, emergency medical service patient care
- 2 reported twenty-eight calls from the Kua Bay area, fourteen
- 3 alone from 2016, with nineteen of the calls resulting in
- 4 hospitalization for a traumatic injury. Additionally, the
- 5 Hawaii Trauma Registry reports that there were seven spinal cord
- 6 injuries from 2009 to 2013. According to the department of
- 7 health's emergency medical services and injury prevention system
- 8 branch's GIS database of fatal drownings, three people have
- 9 drowned in the Kua Bay area since 2013.
- 10 The purpose of this Act is to save lives and prevent injury
- 11 at Kua Bay by appropriating funds for the employment of four
- 12 lifeguards and the purchase of necessary equipment.
- 13 SECTION 2. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$ or so much
- 15 thereof as may be necessary for fiscal year 2019-2020 and the
- 16 same sum or so much thereof as may be necessary for fiscal year
- 17 2020-2021 for the establishment of four full time equivalent
- 18 (4.0 FTE) permanent ocean safety officers for Manini'ōwali beach
- 19 at Kua Bay in Kekaha Kai state park on the island of Hawaii;
- 20 provided that the county of Hawaii shall hire and provide

- 1 benefits for the four full-time equivalent (4.0 FTE) permanent
- 2 ocean safety officer positions established pursuant to this Act.
- 3 The sums appropriated shall be expended by the department
- 4 of land and natural resources for the purposes of this Act.
- 5 SECTION 3. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so much
- 7 thereof as may be necessary for fiscal year 2019-2020 for the
- 8 department of land and natural resources to purchase equipment
- 9 to be used by state ocean safety officers in the course of their
- 10 work at Manini'ōwali beach at Kua Bay in Kekaha Kai state park on
- 11 the island of Hawaii; provided that the sum appropriated shall
- 12 be expended as follows:
- 13 (1) \$ for one lifequard tower;
- 14 (2) \$ for one all-terrain vehicle;
- **15** (3) \$ for radios;
- 16 (4) \$ for rescue equipment; and
- 17 (5) \$ for protective equipment.
- 18 The sum appropriated shall be expended by the department of
- 19 land and natural resources for the purposes of this Act.
- 20 SECTION 4. This Act shall take effect on July 1, 2050.
