## A BILL FOR AN ACT

RELATING TO INVASIVE SPECIES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that responding quickly
- 2 to newly detected invasive species can often prevent the species
- 3 from becoming firmly established, saving taxpayers money in the
- 4 long term. State agencies currently lack the resources and
- 5 response mechanisms to deal with these newly identified threats
- 6 and may be missing opportunities to eliminate them. This can
- 7 allow invasive species to become established in the State,
- 8 making mitigation efforts more protracted and expensive.
- 9 Accordingly, the purpose of this Act is to create a rapid
- 10 response mechanism for invasive species so that newly detected
- 11 threats may be immediately addressed.
- 12 SECTION 2. Chapter 194, Hawaii Revised Statutes, is
- 13 amended by adding a new section to be appropriately designated
- 14 and to read as follows:
- 15 "§194- Invasive species rapid response special fund.
- 16 (a) There is established the invasive species rapid response
- 17 special fund, into which shall be deposited appropriations by

- 1 the legislature for the purposes of mitigating or eradicating
- 2 newly detected invasive species threats in the State. All
- 3 interest earned or accrued on moneys deposited into the fund
- 4 shall become part of the fund. The council shall administer the
- 5 special fund and may expend moneys in accordance with this
- 6 section.
- 7 (b) If the council determines that one or more newly
- 8 detected invasive species pose a substantial threat to the
- 9 agriculture, commerce, economy, environment, or public health of
- 10 the State or otherwise warrant immediate action, the council
- 11 shall submit a request to the governor to declare that there
- 12 exists an invasive species emergency.
- (c) Upon declaration by the governor pursuant to
- 14 subsection (b) that there exists an invasive species emergency,
- 15 the council may act in response to the emergency and may make
- 16 expenditures from the fund without legislative approval and
- 17 without regard to chapters 36, 37, 89, and 103D.
- 18 (d) The council shall make an accounting of moneys
- 19 expended from the fund and shall include that information in its
- 20 annual report to the legislature."

- 1 SECTION 3. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$400,000 or so much
- 3 thereof as may be necessary for fiscal year 2019-2020 and the
- 4 same sum or so much thereof as may be necessary for fiscal year
- 5 2020-2021 for deposit into the invasive species rapid response
- 6 special fund.
- 7 The sums appropriated shall be expended by the department
- 8 of land and natural resources for the purposes of this Act.
- 9 SECTION 4. New statutory material is underscored.
- 10 SECTION 5. This Act shall take effect on July 1, 2019.
