A BILL FOR AN ACT

RELATING TO AN APPROPRIATION FOR A KUNIA WELLS IV EXPLORATORY WELL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that many Oahu farmers
- 2 depend on discounted water rates from the city and county of
- 3 Honolulu board of water supply. The legislature also finds that
- 4 due to new United States Food and Drug Administration Food
- 5 Safety Modernization Act rules, farmers will need greater access
- 6 to potable water for irrigation and crop washing. More
- 7 stringent water quality standards for water supply used to
- 8 irrigate food crops may require increased reliance on potable
- 9 supplies, thereby making existing surface water supplies less
- 10 usable without treatment. The impact to Hawaii farmers and
- 11 water suppliers is uncertain.
- 12 The legislature finds that funding assistance to provide
- 13 alternative water sources would offset some of the costs that
- 14 Oahu farmers would normally pay to start up or expand their
- 15 capacity for diversified agriculture using water from the board
- 16 of water supply.

1	The legislature further finds that the board of water
2	supply adopted a thirty-year water master plan that identifies
3	its water system needs and a schedule of capital improvements.
4	Recently, water rates and charges were established to better
5 ,	align revenues with the costs to serve different customer
6	classes. During this water rate study process, the board of
7	water supply engaged a stakeholder advisory group consisting of
8	water customers, community leaders, landowners, and developers,
9	as well as agricultural, social, and environmental groups. The
10	stakeholder advisory group recognized the benefits of a viable
11	local agricultural industry on Oahu and the importance of an
12	affordable supply of potable water for that industry.
13	The board of water supply's board of directors agreed with
14	the stakeholder advisory group's recommendations and adopted the
15	continuance of the subsidized water rate for agriculture, which
16	is forty per cent lower than the rate for nonresidential
17	ratepayers. New farmers may also incur capacity impact fees,
18	also known as water system facilities charges. Capacity impact
19	fees are used to recover water system capacity that is allocated
20	for growth. The water rate study found that the capacity impact
21	fee also needs to be raised to meet cost of service

- 1 requirements. The last time the capacity impact fee was raised
- 2 was in 1993. This cost increase could have a significant
- 3 economic impact on new farmers.
- 4 The purpose of this Act is to appropriate funds to the
- 5 department of land and natural resources for the board of water
- 6 supply to offset the design and construction costs for one of
- 7 four exploratory water wells proposed by the board of water
- 8 supply for the proposed Kunia wells IV pump station, which will
- 9 provide additional water supply for growth, including
- 10 diversified agriculture. If the funds are used for the design
- 11 or construction of one of four exploratory wells, the board of
- 12 water supply is prepared to pass the benefits of this well to
- 13 offset the impact fees for new farmers to support the
- 14 agriculture industry on Oahu.
- 15 SECTION 2. The director of finance is authorized to issue
- 16 general obligation bonds in the sum of \$ or so much
- 17 thereof as may be necessary and the same sum or so much thereof
- 18 as may be necessary is appropriated for fiscal year 2019-2020
- 19 for the purpose of designing and constructing an exploratory
- 20 well for the proposed Kunia wells IV pump station, as follows:

1 To be expended by the department of land and natural 2 resources (LNR141): 3 A. Proposed Kunia wells IV pump 4 station, Oahu. 5 Design and construction of 6 one exploratory well to meet 7 future potable water 8 requirements for growth, 9 including diversified 10 agriculture. 11 \$1,000,000 Design and Construction 12 Total funding \$1,000,000 13 SECTION 3. The appropriation made for the capital 14 improvement project authorized by this Act shall not lapse at 15 the end of the fiscal biennium for which the appropriation is 16 made; provided that all moneys from the appropriation 17 unencumbered as of June 30, 2022, shall lapse as of that date. 18 SECTION 4. The sums appropriated for the capital project 19 set forth in section 2 shall be expended by the designated 20 expending agency for the purposes of this Act. 21 SECTION 5. This Act shall take effect on July 1, 2019.
