

A BILL FOR AN ACT

RELATING TO WORKFORCE DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that youthbuild is a
- 2 federal workforce development program that provides employment,
- 3 education, leadership development, and training opportunities to
- 4 disadvantaged and low-income youth between the ages of sixteen
- 5 and twenty-four, most of whom are secondary school drop outs and
- 6 are either a member of a low-income family, a foster care youth,
- 7 a youth offender, a youth with a disability, a child of an
- 8 incarcerated parent, or a migrant youth.
- 9 The United States Department of Labor administers the
- 10 youthbuild program by awarding approximately \$89,000,000 in
- 11 grants to about two-hundred youthbuild programs in forty states.
- 12 Program participants receive education services that may lead to
- 13 either a high school diploma or general educational development.
- 14 They also receive occupational skills training and are
- 15 encouraged to pursue a post-secondary education or additional
- 16 training, including registered apprenticeship programs. The
- 17 program is designed to create a skilled workforce either in the

1 construction industry, through the rehabilitation and 2 construction of housing for homeless individuals and families 3 and low-income families, as well as public facilities, or in 4 other high wage, high-demand jobs. The program also benefits 5 the larger community by providing more new and rehabilitated 6 affordable housing. 7 The purpose of this Act is to establish a state youthbuild 8 program to further improve workforce development in Hawaii. 9 SECTION 2. Chapter 371, Hawaii Revised Statutes, is 10 amended by adding a new section to be appropriately designated 11 and to read as follows: 12 "§371- Youthbuild; established. (a) There is 13 established the youthbuild program, hereinafter referred to as 14 the program, which shall be placed within the department for 15 administrative purposes. The program shall provide employment, 16 education, leadership development, and training opportunities to 17 disadvantaged and low-income youth between the ages of sixteen 18 and twenty-four. The department shall establish program 19 requirements that are similar to the youthbuild program 20 administered by the United States Department of Labor.
