A BILL FOR AN ACT

RELATING TO WORKFORCE DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that YouthBuild is a
- 2 federal workforce development program that provides employment,
- 3 education, leadership development, and training opportunities to
- 4 disadvantaged and low-income youth between the ages of sixteen
- 5 and twenty-four, most of whom are secondary school drop outs and
- 6 are either a member of a low-income family, a foster care youth,
- 7 a youth offender, a youth with a disability, a child of an
- 8 incarcerated parent, or a migrant youth.
- 9 The United States Department of Labor administers the
- 10 YouthBuild program by awarding approximately \$85,000,000 in
- 11 grants to one hundred eighty-seven current youthBuild programs
- 12 in forty-seven United States jurisdictions. Program
- 13 participants receive education services that may lead to either
- 14 a high school diploma or general educational development. They
- 15 also receive occupational skills training and are encouraged to
- 16 pursue a post-secondary education or additional training,
- 17 including registered apprenticeship programs. The program is

- 1 designed to create a skilled workforce either in the
- 2 construction industry, through the rehabilitation and
- 3 construction of housing for homeless individuals and families
- 4 and low-income families, as well as public facilities, or in
- 5 other high wage, high-demand jobs. The program also benefits
- 6 the larger community by providing more new and rehabilitated
- 7 affordable housing.
- 8 The purpose of this Act is to further improve workforce
- 9 development in Hawaii by establishing a state youthBuild program
- 10 under the department of labor and industrial relations to assist
- 11 interested non-profit or public entities in applying and
- 12 qualifying for a grant under the federal YouthBuild program.
- 13 SECTION 2. Chapter 371, Hawaii Revised Statutes, is
- 14 amended by adding a new section to be appropriately designated
- 15 and to read as follows:
- 16 "§371- YouthBuild Program; established. (a) There is
- 17 established the youthBuild program, hereinafter referred to as
- 18 the program, which shall be placed within the department for
- 19 administrative purposes. The department shall assist non-profit
- 20 or public entities in applying and qualifying for YouthBuild
- 21 program grants from the United States Department of Labor.

1	(b) The department shall establish program requirements
2	and procedures to assist non-profit or public entities in
3	applying and qualifying for federal YouthBuild program grants.
4	(c) Subject to the availability of funds and requirements
5	established by the department, the department may award grants
6	to eligible non-profit or public entities that have been awarde
7	a federal YouthBuild program grant; provided that any departmen
8	grant awarded under this section:
9	(1) Shall be used toward meeting the federal twenty-five
10	per cent matching funds requirement of the United
11	States Department of Labor YouthBuild program; and
12	(2) May be matched in cash or in-kind contributions by the
13	eligible non-profit or public entity that is awarded
14	grant from the department under this section.
15	(d) The department may adopt rules pursuant to chapter 91
16	to carry out this section."
17	SECTION 3. There is appropriated out of the general
18	revenues of the State of Hawaii the sum of \$ or so
19	much thereof as may be necessary for fiscal year 2019-2020 and
20	the same sum or so much thereof as may be necessary for fiscal
21	year 2020-2021 for administrative costs incurred by the

- 1 department of labor and industrial relations in administering
- 2 the state youthBuild program under this Act.
- 3 The sums appropriated shall be expended by the department
- 4 of labor and industrial relations for the purposes of this Act.
- 5 SECTION 4. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so
- 7 much thereof as may be necessary for fiscal year 2019-2020 and
- 8 the same sum or so much thereof as may be necessary for fiscal
- 9 year 2020-2021 for the department of labor and industrial
- 10 relations to award grants to eligible non-profit or public
- 11 entities that have been awarded a federal YouthBuild program
- 12 grant; provided that any funds awarded pursuant to this section
- 13 shall be used to meet the twenty-five per cent matching funds
- 14 requirement of the United States Department of Labor YouthBuild
- 15 program.
- 16 The sums appropriated shall be expended by the department
- 17 of labor and industrial relations for the purposes of this Act.
- 18 SECTION 5. New statutory material is underscored.
- 19 SECTION 6. This Act shall take effect on January 1, 2050.
