A BILL FOR AN ACT

RELATING TO HUMAN SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there are many 2 opportunities for securing grants from both public and private 3 sources that could be used to support the health and well-being of individuals, families, and communities in the State. 4 The 5 legislature also finds that applying for grants can be time-6 consuming and complex. These challenges make it difficult for 7 agencies like the department of human services and the 8 department of health to successfully apply for and obtain grant moneys, especially when the agencies lack technical expertise in 9 10 grant writing. Additionally, failure to accurately interpret 11 the details of grant requirements may lead to problematic 12 compliance issues. The legislature believes that the department of human services and the department of health would be better 13 14 positioned to take advantage of grant opportunities if they each 15 had a dedicated individual who is responsible for the application for and management of grant opportunities. 16
