

A BILL FOR AN ACT

RELATING TO FAMILIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

The purpose of this Act is to protect the best 1 SECTION 1. interests of children parented or cared for by persons with 2 disabilities by prohibiting the disability of a parent or 3 caregiver from being considered as the sole factor in 4 determining the fitness of any: 5 6 (1) Foster parent or resource family; Prospective adoptive parent of a minor; 7 (2) Prospective guardian of a minor; (3) Person seeking custody or visitation of a minor child; (4) 10 orParent or caregiver when evaluating whether a child's 11 (5) 12 family is willing and able to provide the child with a safe family home. 13 SECTION 2. Chapter 346, Hawaii Revised Statutes, is 14 amended by adding a new section to part I to be appropriately 15

designated and to read as follows:

1	"§346- Department standards and requirements;
2	disability. The department shall not consider the disability of
3	a person to be the sole factor in making a determination under
4	section 346-17 or section 346-19.7. If the department makes a
5	determination to deny the petition of a disabled person under
6	section 346-17 or section 346-19.7, the department shall make
7	specific written findings stating the basis for the
8	determination."
9	SECTION 3. Chapter 560, Hawaii Revised Statutes, is
10	amended by adding a new section to article V, part 2 to be
11	appropriately designated and to read as follows:
12	"§560:5- Judicial appointment of guardian; disability.
13	The court shall not consider the disability of a prospective
14	guardian to be the sole factor in the court's determination to
15	approve or deny the appointment of a guardian pursuant to this
16	part. If the court makes a determination to deny guardianship
17	to a person who is disabled, the court shall make specific
18	written findings stating the basis for this determination."
19	SECTION 4. Chapter 571, Hawaii Revised Statutes, is
20	amended by adding a new section to part V to be appropriately
21	designated and to read as follows:

1	"§571- Criteria and procedure in awarding custody and
2	visitation; disability. The court shall not consider the
3	disability of a person seeking custody or visitation of a minor
4	to be the sole factor in the court's determination made pursuant
5	to this part. If the court makes a determination to deny
6	custody or visitation to a person who is disabled, the court
7	shall make specific written findings stating the basis for this
8	determination."
9	SECTION 5. Chapter 587A, Hawaii Revised Statutes, is
10	amended by adding a new section to part III to be appropriately
11	designated and to read as follows:
12	"§587A- Safe family home factors; disability. The
13	court shall not consider the disability of a parent or caregiver
14	to be the sole factor in the court's determination made pursuant
15	to this part. If the court makes a determination that a child's
16	family is unable to provide a safe family home and one or more
17	of the child's parents or caregivers are disabled, the court
18	shall make specific written findings stating the basis for this
19	determination."

- 1 SECTION 6. This Act does not affect rights and duties that
- 2 matured, penalties that were incurred, and proceedings that were
- 3 begun before its effective date.
- 4 SECTION 7. New statutory material is underscored.
- 5 SECTION 8. This Act shall take effect upon its approval.
