A BILL FOR AN ACT

RELATING TO INTERNAL REVENUE CODE SECTION 501(C)(4) ORGANIZATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended 1 by adding a new section to part XIII to be appropriately 2 3 designated and to read as follows: 4 Internal Revenue Code section 501(c)(4) "§11organizations; disclosures; communications. (a) An 5 organization that is exempt from federal taxation under Internal 6 Revenue Code section 501(c)(4) shall file semi-annual reports 7 8 with the commission if the organization directly spends more 9 than \$10,000 in a calendar year, or provides another entity with 10 more than \$10,000 in a calendar year, to make one or more 11 communications that refer to and advocate for, or against, a 12 clearly identified elected official or the position of any 13 elected official related to an official government action. 14 (b) The reports shall be made on forms created by the 15 commission and shall identify any donor that gave the organization \$1,000 or more during the six-month reporting 16

I	period, regardless of whether the donor intended to fund any	
2	election activity.	
3	(c)	The semi-annual reports shall be filed with the
4	commission	on June 30 and December 31 of each year.
5	(d)	This section shall not apply if:
6	(1)	The communications are sent to persons who:
7		(A) Contribute funds to the organization;
8		(B) Are members of the organization; or
9		(C) Have the right to vote on organizational matters
10		relating to the organization;
11	(2)	The communications are made to the media or relate to
12		efforts to promote non-partisan debates or similar
13		forums; or
14	(3)	The organization files preliminary, final, and
15		supplemental reports with the commission as a
16		noncandidate committee.
17	<u>(e)</u>	For the purposes of this section, the term
18	"communications" includes internet communications such as online	
19	advertisements, websites, social media pages, and mass emails."
