### A BILL FOR AN ACT

RELATING TO STANDARDIZED TESTING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the federal No Child
- 2 Left Behind Act of 2001 and Race to the Top program in 2009
- 3 shifted national education priorities from inquiry-based
- 4 teaching to standardized testing. Following the enactment of
- 5 these laws, Hawaii's public school system spent growing amounts
- 6 of time, money, and energy on standardized testing at the
- 7 expense of authentic learning.
- 8 The legislature further finds that an overemphasis on
- 9 standardized testing narrows academic curricula, reducing arts
- 10 and cultural education, causing teachers to teach for the
- 11 standardized testing, decreasing vocational programming, and
- 12 creating a climate of compliance and fear among students,
- 13 teachers, and administrators. Moreover, research shows that the
- 14 negative impacts of standardized testing do most direct harm to
- 15 students in low-income communities.
- 16 The legislature additionally finds that the federal Every
- 17 Student Succeeds Act in 2015 permits states to reduce the amount

- 1 of time that students spend preparing for and taking
- 2 standardized tests. Accordingly, the purpose of this Act is to
- 3 promote real-world learning experiences for Hawaii's children by
- 4 limiting the amount of time students spend studying for and
- 5 participating in standardized testing.
- 6 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 7 amended by adding a new section to be appropriately designated
- 8 and to read as follows:
- 9 "\$302A- Standardized testing limitations; op out. (a)
- 10 Beginning with the 2020-2021 school year, the department shall
- 11 only administer standardized tests that are required by state
- 12 and federal law.
- (b) The board shall notify students and their parents or
- 14 guardians about the right to opt out of participating in
- 15 standardized testing.
- (c) For the purpose of this section:
- 17 "Standardized testing" means any assessment that is scored
- 18 in a consistent manner and intended to measure a student's
- 19 academic readiness, achievement level, learning progress, or
- 20 skill acquisition, including any diagnostic, interim, or
- 21 practice test used to prepare for such an assessment."

- 1 SECTION 3. Section 302A-638, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "[+]\$302A-638[+] Evaluation of teachers and educational
- 4 officers. The department shall establish an evaluation program
- 5 for all teachers and educational officers. The evaluation shall
- 6 be performed at least once in each school year. The program
- 7 shall define the criteria for evaluation and assign
- 8 responsibilities for the application of the criteria. The
- 9 evaluation of a teacher or educational officer shall be on the
- 10 basis of efficiency, ability, and such other criteria as the
- 11 department shall determine [-]; provided that standardized tests
- 12 results shall not be used to evaluate the performance of any
- 13 teacher or educational officer, including in any evaluation
- 14 performed under this section."
- 15 SECTION 4. The board of education shall amend any
- 16 necessary board policies relating to standardized testing or the
- 17 evaluation of teachers and educational officers to conform with
- 18 the requirements of this Act.
- 19 SECTION 5. Statutory material to be repealed is bracketed
- 20 and stricken. New statutory material is underscored.

1 SECTION 6. This Act shall take effect upon its approval.

### Report Title:
