A BILL FOR AN ACT

RELATING TO THE HAWAII TOURISM AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I. GENERAL PROVISIONS
2	SECTION 1. The purpose of this Act is to establish the
3	operating budget for the fiscal biennium beginning July 1, 2019,
4	and ending June 30, 2021, for state executive branch programs
5	under the purview of the house of representatives standing
6	committee on tourism and international affairs.
7	SECTION 2. DEFINITIONS. Unless otherwise clear from the
8	context, as used in this Act:
9	"Expending agency" means the department of business,
10	economic development, and tourism.
11	Abbreviations, where used to denote the expending agency or
12	a house of representatives standing committee, shall mean the
13	following:

16	TIA House of representatives standing committee on tourism

- "Means of financing" or "MOF" means the source from which 1 funds are appropriated or authorized to be expended for the 2 programs and projects specified in this Act. All appropriations 3 are followed by letter symbols. The letter symbols, where used, 4 shall have the following meanings: 5 Special funds 6 "Position ceiling" means the maximum number of permanent 7 and temporary full-time equivalent positions authorized for a 8 particular program during a specified period or periods, as 9 denoted by an asterisk for permanent full-time equivalent 10 positions and a pound sign for temporary full-time equivalent 11 12 positions. "Program ID" means the unique identifier for the specific 13 program and consists of the abbreviation for the organization 14 responsible for carrying out the program followed by the 15 organization number for the program. 16

SECTION 3. APPROPRIATIONS. The following sums, or so much thereof as may be sufficient to accomplish the purposes and programs designated herein, are hereby appropriated or authorized, as the case may be, from the means of financing specified to the expending agencies designated for the fiscal
