

A BILL FOR AN ACT

RELATING TO CONTROVERSIAL PUBLIC SCHOOL CURRICULUM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that parents of students
- 2 have the right to be fully informed on subjects and lessons
- 3 taught to their children in public schools. If public schools
- 4 are teaching materials and courses that some parents find
- 5 incompatible with their own values, the schools should be as
- 6 transparent about their teachings as possible.
- 7 The Board of Education's Policy 101.13 concerning
- 8 controversial issues discussed in the classroom does not include
- 9 parental notification or an opt-out clause. Currently, the
- 10 Department of Education mentions an opt-out process on their
- 11 website, but there is no existing codified policy regarding the
- 12 ability for a parent to be notified of controversial topics or
- 13 to choose to opt-out of participation.
- 14 The purpose of this Act is to promote transparency and
- 15 accountability by requiring public schools to disclose all
- 16 controversial content to parents seven days before such
- 17 instructional materials are circulated to students.

1	SECTION 2. Chapter 302-A, Hawaii Revised Statutes, is
2	amended by adding a new section to part II to be appropriately
3	designated and to read as follows:
4	"§302A- Education on controversial issues. (a)
5	Notwithstanding any law to the contrary, a public school shall
6	provide written notice to the parents or legal guardians of a
7	student no less than seven days before providing the student
8	with instructions or instructional materials that are
9	controversial in nature. The notification shall give enough
10	detailed information for the parent or legal guardian to make ar
11	informed decision for their child. A student shall not receive
12	the instructions or instructional materials if a parent or legal
13	guardian submits a written objection to the public school.
14	(b) This section shall not be construed to prohibit the
15	board, the department, or a public school from implementing or
16	complying with policies that require affirmative consent from a
17	parent or legal guardian before the school provides instruction
18	or instructional materials to a student.
19	(c) For purposes of this section:
20	"Controversial" means likely to provoke strong disagreement
21	among reasonable people.

1	"Instruction" includes curriculum, classes, supplementary
2	lectures and classes, and educational activities that take place
3	during school hours or in afterschool programs.
4	"Instructional materials" include textbooks, curriculum
5	pamphlets, supplementary materials, electronic data, or
6	audiovisual media relating to the instruction of an issue."
7	SECTION 3. New statutory material is underscored.
8	SECTION 4. This Act shall take effect upon approval.
