

### A BILL FOR AN ACT

RELATING TO SCHOOL SPONSORSHIP NAMING RIGHTS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that as the cost of
- 2 education has increased, schools and governments have
- 3 increasingly sought alternative sources of funding. Many
- 4 schools and school districts throughout the United States and
- 5 the world have allowed schools to accept private contributions
- 6 to lessen the burden on taxpayers.
- 7 The legislature further finds that one common method of
- 8 obtaining funding for schools is by authorizing schools to
- 9 accept donations in exchange for the naming rights of something
- 10 as large as a field or a building to something as small as a
- 11 shelf in the library.
- 12 The purpose of this Act is to authorize department of
- 13 education schools, subject to approval by the superintendent, to
- 14 accept donations in exchange for sponsorship naming rights.
- 15 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 16 amended by adding a new section to part VI, subpart A, to be
- 17 appropriately designated and to read as follows:

1	"§302A- Sponsorship naming rights. (a)
2	Notwithstanding section 102-2, each school, subject to approval
3	of the superintendent, may accept donations in exchange for the
4	sponsorship naming rights of any school building, facility,
5	equipment, or fixture.
6	(b) There is established within the state treasury a
7	special fund to be known as the school naming rights special
8	fund. The special fund shall be administered by the department
9	and appropriate subaccounts shall be established for each
10	school. All moneys collected pursuant to subsection (a) shall
11	be deposited into the corresponding school subaccount and shall
12	be expended solely for the benefit of that school.
13	(c) The department shall submit a report to the
14	legislature no later than twenty days prior to the convening of
15	each regular session that shall include all donations accepted
16	pursuant to subsection (a) during the previous fiscal year, all
17	naming rights awarded pursuant to subsection (a) during the
18	previous fiscal year, and the amount of moneys in the special
19	fund established pursuant to subsection (b) at the end of the
20	previous fiscal year.

- 1 (d) The department shall adopt rules pursuant to chapter
- 2 91 to carry out the purposes of this section."
- 3 SECTION 3. New statutory material is underscored.
- 4 SECTION 4. This Act shall take effect upon its approval.
