RELATING TO DISABLED PERSONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 78, Hawaii Revised Statutes, is amended
2	by adding a new section to be appropriately designated and to
3	read as follows:
4	" <u>§78-</u> Employment first; disabled persons. (a)
5	Employment first shall be a policy of the State and the
6	counties. State and county agencies shall ensure that
7	employment first is effectively implemented in hiring and all
8	programs and services administered or funded by the State and
9	counties, including programs and services that help disabled
10	persons obtain employment. All state and county agencies shall
11	coordinate efforts and collaborate to ensure that programs,
12	policies, procedures, and funding support competitive employment
13	in an integrated setting for disabled persons. All state and
14	county agencies, whenever feasible, shall share data and
15	information to track progress toward full implementation of this
16	section.

1	(b) Nothing in this section shall be construed to require			
2	any employer to give preference to hiring a disabled person.			
3	(c) Nothing in this section shall be construed as			
4	eliminating any other appropriate supported employment service.			
5	(d) As used in this section:			
6	"Competitive employment" means work in the competitive			
7	labor market that is performed on a full-time or part-time basis			
8	in an integrated setting, and for which a disabled person is			
9	compensated at or above the minimum wage, but not less than the			
10	customary wage and level of benefits paid by the employer for			
11	the same or similar work performed by nondisabled persons.			
12	"Employment first" means the full inclusion of disabled			
13	persons in the workplace and community through integrated			
14	employment as the first option for employment services for			
15	adults and children of working age who are disabled.			
16	"Employment first" includes competitive employment in an			
17	integrated setting.			
18	"Integrated setting" means an employment setting in which			
19	disabled persons interact with nondisabled persons, other than			
20	nondisabled persons who are providing services to those disabled
