A BILL FOR AN ACT

RELATING TO HARBORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 200, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 Harbors; small vessel; mooring during inclement "§200-5 weather and dangerous ocean conditions. Notwithstanding any law 6 to the contrary, the department shall allow, on a space 7 available basis, a small vessel to moor in any harbor under the 8 jurisdiction of the department at no additional cost and with no 9 use permit required in the event of inclement weather or ocean 10 conditions; provided that the department shall determine that 11 the entry and mooring of the small vessel shall be conducted in 12 a safe manner; and provided further that as soon as the 13 department opens the entrance to vessels, the small vessel shall 14 leave the harbor. 15 The chairperson shall adopt rules pursuant to chapter 91 to 16 implement this section, including requirements for size and use 17 of a vessel to qualify as a small vessel under this section."

2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	" <u>§266-</u> Harbors; small vessel; mooring during inclement
5	weather and dangerous ocean conditions. Notwithstanding any law
6	to the contrary, the department of transportation shall allow,
7	on a space available basis, a small vessel to moor in any harbor
8	under the jurisdiction of the department of transportation at no
9	additional cost and with no use permit required in the event of
10	inclement weather or ocean conditions; provided that the
11	department of transportation shall determine that the entry and
12	mooring of the small vessel shall be conducted in a safe manner;
13	and provided further that as soon as the department of
14	transportation opens the entrance to vessels, the small vessel
15	shall leave the harbor.
16	The director of transportation shall adopt rules pursuant
17	to chapter 91 to implement this section, including requirements
18	for size and use of a vessel to qualify as a small vessel under
19	this section."
