A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Reinventing
- 2 Education Act of 2004, Act 51, Session Laws of Hawaii 2004,
- 3 established, among other things, a weighted student formula to
- 4 allocate moneys to schools according to the different costs of
- 5 educating students with different needs. Despite the intended
- 6 equitable distribution of funds, the weighted student formula
 - 7 places small, remote schools at a disadvantage. For example, in
 - 8 the case of Hana high and elementary school, a budgetary
 - 9 shortfall resulted in the loss of several well-qualified
- 10 teachers and threatened the school's ability to offer minimum
- 11 course requirements for students to earn high school diplomas.
- 12 As of 2005, six schools were excepted from weighted student
- 13 formula allocations.
- 14 The legislature further finds that remote schools should be
- 15 funded to retain the minimum personnel and resources necessary
- 16 to graduate students.

- 1 Accordingly, the purpose of this Act is to improve funding
- 2 equity for remote schools.
- 3 SECTION 2. Section 302A-1303.6, Hawaii Revised Statutes,
- 4 is amended to read as follows:
- 5 "§302A-1303.6 Weighted student formula[-]; remote schools;
- 6 funding. (a) Based upon recommendations from the committee on
- 7 weights, the board of education may adopt a weighted student
- 8 formula for the allocation of moneys to public schools that
- 9 takes into account the educational needs of each student. [The]
- 10 Except as otherwise provided in subsection (b), the department,
- 11 upon the receipt of appropriated moneys, shall use the weighted
- 12 student formula to allocate funds to public schools.
- 13 Principals, in consultation with teachers and school community
- 14 councils, shall expend moneys provided to the principals'
- 15 schools. This section shall only apply to charter schools for
- 16 fiscal years in which the charter schools elect pursuant to
- 17 section 302D-29 to receive allocations according to the
- 18 procedures and methodology used to calculate the weighted
- 19 student formula allocation.
- 20 (b) For the purposes of subsection (a), a remote school,
- 21 as defined in subsection (c), and other schools designated by

16	(C)	For the purposes of this section:
17	"Con	sumer price index" means the national consumer price
18	index ave	rage over a twelve-month period that is published
19	monthly b	y the United States Department of Labor's Bureau of
20	Labor Statistics as the "National Consumer Price Index for All	
21	Hrhan Con	cumors - Inited States City Average"

1	"Inflation-adjusted minimum level of funding" means the		
2	total amount of funding provided to the school in the fiscal		
3	year 2019-2020; provided that this amount shall increase by		
4	three per cent for each subsequent fiscal year.		
5	"Remote school" means any public school, as defined in		
6	section 302A-101, except charter schools governed by chapter		
7	302D, that is a high school located:		
8	(1) At least a one-hour drive away from the next nearest		
9	<pre>public high school; or</pre>		
10	(2) On the island of Lanai, Molokai, or Niihau; provided		
11	that if a high school is combined with an elementary,		
12	middle, intermediate, or other lower level of		
13	schooling, the entire school shall be deemed a high		
14	school for the purposes of this subsection."		
15	SECTION 3. There is appropriated out of the general		
16	revenues of the State of Hawaii the sum of \$ or so much		
17	thereof as may be necessary for fiscal year 2019-2020 and the		
18	same sum or so much thereof as may be necessary for fiscal year		
19	2020-2021 for the department of education to provide additional		
20	per-pupil funding to remote schools.

- 1 The sums appropriated shall be expended by the department
- 2 of education for the purposes of this Act.
- 3 SECTION 4. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 5. This Act shall take effect on July 1, 2019.
