

A BILL FOR AN ACT

RELATING TO TELECOMMUNICATIONS CARRIERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 269, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§269- Telecommunications carriers; residential or
5	personal lines; blocked calls. (a) Every telecommunications
6	carrier shall automatically block any call made to a residential
7	phone line or a personal mobile phone line of a customer
8	domiciled in this State if the telephone number of the caller
9	does not belong to:
10	(1) A provider of ambulance, police, fire, and other
11	emergency services in this State, whether the provider
12	is a governmental agency or under contract with a
13	<pre>governmental agency;</pre>
14	(2) A governmental agency of this State or any of its
15	counties, or the federal government;
16	(3) A financial institution licensed under chapter 412;

1	(4)	A business entity registered with the department of
2		commerce and consumer affairs to do business in this
3		State;
4	(5)	A professional entity licensed by the department of
5		commerce and consumer affairs, the department of
6		health, the judiciary, or a county, to offer
7		professional services in this State or a county, if
8		the professional entity is licensed by a county;
9	(6)	An organization that is exempt from federal taxation
10		under section 501(c) of the Internal Revenue Code of
11		1986, as amended, and domiciled in this State; or
12	(7)	A residential phone line or personal mobile phone line
13		that is verified as being associated with the account
14		of a customer of a telecommunications carrier
15		registered to do business in or outside of this State.
16	(b)	The carrier shall unblock a call made to a customer
17	from a te	lephone number that would otherwise be blocked pursuant
18	to subsec	tion (a); provided that the customer provides the
19	carrier w	ith a written notice of specific telephone numbers that
20	the custo	mer elects to unblock.

1	(c) The carrier shall block a call made to a customer from
2	a telephone number that would otherwise be unblocked pursuant to
3	subsection (a); provided that the customer provides the carrier
4	with a written notice of specific telephone numbers that the
5	customer elects to block; provided that this subsection shall
6	not apply to calls made from an entity described under
7	subsection (a)(1) and (2)."
8	SECTION 2. New statutory material is underscored.
9	SECTION 3. This Act shall take effect upon its approval.
