
A BILL FOR AN ACT

RELATING TO CAREER TECHNICAL EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. (a) There is established within the department
2	of educat	ion the seal of career technical education pilot
3	program.	The purpose of the pilot program shall be to:
4	(1)	Encourage students to study career technical
5		education;
6	(2)	Encourage the department of education to provide high-
7		quality career technical education pathways leading to
8		industry-recognized certifications or licenses;
9	(3)	Certify and recognize high achievement within career
10		technical education pathways;
11	(4)	Provide students with a tool to demonstrate
12		occupational competency to prospective employers;
13	(5)	Provide postsecondary educational institutions with a
14		method to recognize and give academic credit to
15		students;
16	(6)	Prepare students with career-ready skills; and
17	(7)	Engage students in career exploration at an early age.

1	(b)	The department of education shall award a seal of
2	career te	chnical education to each student that has:
3	(1)	Attained a 2.5 grade point average or higher on a 4.0
4		scale for a sequence of career technical education
5		courses taken in high school;
6	(2)	Earned an industry recognized career technical
7		education credential or certificate;
8	(3)	Provided proof of enrollment in a postsecondary
9		apprenticeship, certificate, credential, or degree
10		program;
11	(4)	Participated in a state recognized career technical
12		student organization that meets regularly, and either
13		participates in or organizes events relating to the
14		career technical education pathway or related industry
15		sector at a sectional, regional, state, or national
16		level;
17	(5)	Participated in career-technical-education-based
18		competitions at a sectional, regional, state, or
19		national level; and

1	(6)	Participated in an internship provided by a local
2		employer or organization that advances the student's
3		career readiness skills.
4	(c)	The department of education shall:
5	(1)	Provide students with support staff and programs to
6		ensure equitable student access and success in
7		completing pilot program requirements and evaluating
8		postsecondary options, including counselors and
9		tutoring programs;
10	(2)	Affix an appropriate insignia to the diploma and
11		transcript of each graduate who earns a seal of career
12		technical education; and
13	(3)	Maintain appropriate records to identify graduates who
14		have earned a seal of career technical education.
15	(d)	No fee shall be charged to a student to receive a seal
16	of career	technical education.
17	(e)	The board of education may prescribe additional
18	requiremen	nts for the purposes of this Act.




