A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS BUDGET.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I. GENERAL PROVISIONS							
2	SECTION 1. The purpose of this Act is to establish the							
3	operating budget for the fiscal biennium beginning July 1, 2019,							
4	and ending June 30, 2021, for state executive branch programs							
5	under the purview of the house of representatives standing							
6	committee on water, land, and Hawaiian affairs.							
7	SECTION 2. Unless otherwise clear from the context, as							
8	used in this Act:							
9	"Expending agency" means the department of Hawaiian home							
10	lands.							
11	Abbreviations, where used to denote the expending agency or							
12	a house of representatives standing committee, shall mean the							
13	following:							
14	HHL Department of Hawaiian home lands							
15	WLH House of representatives standing committee on water,							
16	land, and Hawaiian affairs

- 1 "Means of financing" or "MOF" means the source from which
- 2 funds are appropriated or authorized to be expended for the
- 3 programs and projects specified in this Act. All appropriations
- 4 are followed by letter symbols. The letter symbols, where used,
- 5 shall have the following meanings:
- 6 A General funds
- 7 B Special funds
- 8 N Federal funds
- 9 T Trust funds
- 10 "Position ceiling" means the maximum number of permanent
- 11 and temporary full-time equivalent positions authorized for a
- 12 particular program during a specified period or periods, as
- 13 denoted by an asterisk for permanent full-time equivalent
- 14 positions and a pound sign for temporary full-time equivalent
- 15 positions.
- 16 "Program ID" means the unique identifier for the specific
- 17 program and consists of the abbreviation for the organization
- 18 responsible for carrying out the program followed by the
- 19 organization number for the program.

1 PART II. PROGRAM APPROPRIATIONS

- 2 SECTION 3. The following sums, or so much thereof as may
- 3 be sufficient to accomplish the purposes and programs designated
- 4 herein, are hereby appropriated or authorized, as the case may
- 5 be, from the means of financing specified to the expending
- 6 agency designated for the fiscal biennium beginning July 1,
- 7 2019, and ending June 30, 2021. The total expenditures and the
- 8 number of positions in each fiscal year of the biennium shall
- 9 not exceed the sums and the position ceilings indicated for each
- 10 fiscal year, except as provided elsewhere in this Act or as
- 11 provided by general law.

- 2 SECTION 4. If any portion of this Act or its application
- 3 to any person, entity, or circumstance is held to be invalid for
- 4 any reason, then the legislature declares that the remainder of
- 5 this Act and each and every other provision thereof shall not be
- 6 affected thereby. If any portion of a specific appropriation is
- 7 held to be invalid for any reason, the remaining portion shall
- $oldsymbol{8}$ be expended to fulfill the objective of the appropriation to the
- 9 extent possible.
- 10 SECTION 5. If manifest clerical, typographical, or other
- 11 mechanical errors are found in this Act, the governor may
- 12 correct the errors.
- 13 SECTION 6. This Act shall take effect on July 1, 2030.
