A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2019-2020 and the same sum or so much thereof as may be necessary for fiscal year 2020-2021 for the purchase of equipment to effectively respond

- 6 to emergencies in forest reserves and state lands by the
- 7 division of forestry and wildlife (LNR172).
- 8 The sums appropriated shall be expended by the department

There is appropriated out of the general 11 revenues of the State of Hawaii the sum of \$ or so much 12 thereof as may be necessary for fiscal year 2019-2020 and the 13 sum of \$ or so much thereof as may be necessary for 14 fiscal year 2020-2021 to invest in forest products in the Hawaii 15 forest reserve system (LNR172). 16 The sums appropriated shall be expended by the department **17** of land and natural resources for the purposes of this Act. 18 SECTION 5. There is appropriated out of the general 19 revenues of the State of Hawaii the sum of \$ or so much 20 thereof as may be necessary for fiscal year 2019-2020 and
