A BILL FOR AN ACT

RELATING TO A STATE LOTTERY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Hawaii Revised Statutes is amended by
2	adding a new chapter to be appropriately designated and to read
3	as follows:
4	"CHAPTER
5	STATE LOTTERY
6	§ -1 Definitions. As used in this chapter, unless the
7	context otherwise requires:
8	"Charitable organization" means any nonprofit organization,
9	including not more than one auxiliary of that organization, that
10	has operated for charitable purposes in this State for at least
11	two years before submitting a license application under this
12	chapter.
13	"Commission" or "lottery commission" means the Hawaii state
14	lottery commission.
15	"Executive director" means the executive director of the
16	Hawaii state lottery commission.

- 1 "Game play-style" means the process or procedure that a
- 2 player shall follow to determine if a lottery ticket or share is
- 3 a winning ticket or share.
- 4 "Lottery" or "state lottery" means the lottery created and
- 5 operated pursuant to this chapter.
- 6 "Matrix" means the odds of winning a prize and the prize
- 7 payout amounts in a given game.
- 8 "Person" means an individual, association, corporation,
- 9 club, trust, estate, society, company, joint stock company,
- 10 receiver, trustee or referee, any other person acting in a
- 11 fiduciary or representative capacity who is appointed by a
- 12 court, or any combination of individuals. "Person" includes any
- 13 department, commission, agency, or instrumentality of the State
- 14 or its political subdivisions.
- 15 "Premises" means the physical location and address listed
- 16 on the license of the licensed agent where lottery tickets or
- 17 shares may be sold.
- 18 § -2 Hawaii state lottery commission; membership,
- 19 appointment; chairperson; reimbursement of expenses. (a) There
- 20 is established within the department of accounting and general
- 21 services for administrative purposes only a Hawaii state lottery

- 1 commission consisting of five members who shall be residents of
- 2 this State and appointed by the governor pursuant to section 26-
- 3 34. No more than three members of the commission may be from
- 4 the same political party. The commission members shall annually
- 5 elect one of the members to serve as chairperson of the
- 6 commission.
- 7 (b) The commission shall comprise the following members:
- $oldsymbol{8}$ (1) At least one member of the commission shall have a
- 9 minimum of five years' experience in law enforcement;
- 10 (2) At least one member of the commission shall have a
- minimum of five years' experience as a certified
- 12 public accountant;
- 13 (3) At least one member of the commission shall have a
- 14 minimum of five years' experience in marketing or
- advertising, or both; and
- 16 (4) At least one member of the commission shall have a
- minimum of five years' experience in convenience
- store, minimart, or grocery retailing.
- 19 (c) The members of the commission shall serve without
- 20 compensation but shall be reimbursed for expenses, including
- 21 travel expenses, necessary for the performance of their duties.

- 1 (d) No commission member shall have a pecuniary interest
- 2 in any contract or agreement to which the commission is a party.
- 3 (e) No action of the commission shall be binding unless
- 4 taken at a meeting with at least three members present who vote
- 5 in favor of the action in question.
- 6 § -3 Executive director; appointment. (a) The governor
- 7 shall appoint an executive director who shall be a person
- 8 qualified by training and experience to administer the state
- 9 lottery.
- 10 (b) Effective July 1, 2019, the executive director shall
- 11 be paid a salary set at eighty-seven per cent of the salary of
- 12 the director of human resources development. The executive
- 13 director shall be exempt from chapters 76 and 89 but shall be a
- 14 member of the state employees' retirement system and shall be
- 15 eligible to receive benefits of any state or federal employee
- 16 benefits program generally applicable to officers and employees
- 17 of the State, including those under chapter 87A.
- 18 (c) The executive director shall devote the executive
- 19 director's entire time and attention to the administration of
- 20 the state lottery and shall not be engaged in any other
- 21 profession or occupation.



1	(d) The executive director may employ persons not subject
2	to chapters 76 and 78 to perform and execute the functions of
3	the commission.
4	§ -4 Commission; executive director; powers and duties.
5	(a) The commission shall meet with the executive director not
6	less than once each quarter to make recommendations and set
7	policy, receive reports from the executive director, and
8	transact other business properly brought before the commission.
9	(b) The commission shall oversee a state lottery to
10	produce the maximum amount of net revenue consistent with the
11	dignity of the State. To achieve these ends, the commission
12	shall authorize the executive director to adopt rules in
13	accordance with chapter 91. Rules adopted by the executive
14	director may include provisions relating to:
15	(1) Subject to the approval of the commission, the types
16	of lottery games and the types of game play-styles to
17	be conducted;
18	(2) The method of selecting the winning tickets or shares
19	for noncomputerized online games; provided that no
20	method may be used that, in whole or in part, depends
21	on the results of a dog race or a horse race;

1	(3)	The manner of payment of prizes to the holders of
2		winning tickets or shares, including providing for
3		payment by the purchase of annuities in the case of
4		prizes payable in installments; provided that the
5		commission staff shall examine claims and shall not
6		pay any prize based on altered, stolen, or counterfeit
7		tickets or based on any tickets that fail to meet
8		established validation requirements, including rules
9		stated on the ticket or in the published game rules,
10		and confidential validation tests applied consistently
11		by the commission staff. No particular prize in a
12		lottery game may be paid more than once, and if a
13		binding determination occurs in which more than one
14		person is entitled to a particular prize, the sole
15		remedy of the claimants is the award to each of them
16		of an equal portion of the single prize;
17	(4)	The method to be used in selling tickets or shares;
18		provided that no elected official's name may be
19		printed on the tickets or shares. The overall
20		estimated odds of winning some prize or some cash

1		prize, as appropriate, in a given game shall be
2		printed on each ticket or share;
3	(5)	The licensing of agents to sell tickets or shares;
4		provided that no person who is under eighteen years of
5		age shall be licensed as an agent;
6	(6)	The manner and amount of compensation to be paid
7		licensed sales agents necessary to provide for the
8		adequate availability of tickets or shares to
9		prospective buyers and for the convenience of the
10		public, including provision for variable compensation
11		based on sales volume; and
12	(7)	Matters necessary or desirable for the efficient and
13		economical operation and administration of the lottery
14		and for the convenience of the purchasers of tickets
15		or shares and the holders of winning tickets or
16		shares.
17	(c)	The commission shall authorize the executive director
18	to issue	orders and shall approve orders issued by the executive
19	director	for the necessary operation of the lottery. Orders
20	issued un	nder this subsection may include provisions relating to
21	(1)	The prices of tickets or shares in lottery games;

1	(2)	The themes, game play-styles, and names of lottery
2		games and definitions of symbols and other characters
3		used in lottery games; provided that each ticket or
4		share in a lottery game shall bear a unique and
5		distinguishable serial number;
6	(3)	The sale of tickets or shares at a discount for
7		promotional purposes;
8	(4)	The prize structure of lottery games, including the
9		number and size of prizes available. Available prizes
10		may include free tickets in lottery games and
11		merchandise prizes;
12	(5)	The frequency of drawings, if any, or other selections
13		of winning tickets or shares; provided that:
14		(A) All drawings shall be open to the public;
15		(B) The actual selection of winning tickets or shares
16		shall not be performed by an employee or member
17		of the commission; and
18		(C) Noncomputerized online game drawings shall be
19		witnessed by an independent observer;
20	(6)	Requirements for eligibility for participation in
21		grand drawings or other runoff drawings, including

1		requirements for the submission of evidence of
2		eligibility within a shorter period than that provided
3		for claims by section -21; and
4	(7)	Incentive and bonus programs designed to increase
5		sales of lottery tickets or shares and to produce the
6		maximum amount of net revenue for the State.
7	(d)	Notwithstanding chapter 91 and subsection (b), the
8	executive	director, subject to the approval of the commission,
9	may estab	lish a policy, procedure, or practice that relates to
10	an existin	ng online game or a new online game that is the same
11	type and h	has the same type of game play-style as an online game
12	currently	being conducted by the lottery or may modify an
13	existing :	rule for an existing online game or a new online game
14	that is tl	ne same type and has the same type of game play-style
15	as an onl	ine game currently being conducted by the lottery,
16	including	establishing or modifying the matrix for an online
17	game by g	iving notice of the establishment or modification at
18	least thi	rty days before the effective date of the establishment
19	or modifie	cation.

1	(e)	The	commission	shall	maintain	and	make	the	following

- 2 information available for public inspection at its offices
- 3 during regular business hours:
- 4 (1) A detailed listing of the estimated number of prizes
 5 of each particular denomination expected to be awarded
 6 in any instant game currently on sale;
- 7 (2) After the end of the claim period prescribed by
 8 section -21, a listing of the total number of
 9 tickets or shares sold and the number of prizes of
 10 each particular denomination awarded in each lottery
 11 game; and
 - (3) Definitions of all play symbols and other characters used in each lottery game and instructions on how to play and how to win each lottery game.
- (f) Any information that is maintained by the commission
 that would assist a person in locating or identifying a winning
 ticket or share or that would otherwise compromise the integrity
 of any lottery game shall be deemed confidential and shall not
 be subject to public inspection.

1 The commission, in addition to other games authorized (q) by this chapter, shall establish two special games for each year 2 to be conducted concurrently with other lottery games authorized 3 4 under subsection (b). The moneys for prizes, for operating 5 expenses, and for payment to the department of education, as 6 provided in section -25(b), shall be accounted for separately 7 as nearly as practicable in the commission's general accounting system. The moneys shall be derived from the revenues of the 8 9 special games, and moneys for prizes shall not be expended from **10** the commission's annual appropriation, except as otherwise 11 provided in section -5(d) and section -25. Moneys saved from the revenues of the special games, by reason of operating 12 efficiencies, shall become other revenue of the commission and 13 14 revert to the state general fund. 15 The commission, in addition to other games authorized (h) by this chapter, may establish multistate lottery games with the 16 lottery commissions of other states to be conducted concurrently **17** 18 with other lottery games authorized under subsections (b) and The moneys for prizes, for operating expenses, and for 19 payment to the state general fund shall be accounted for 20 21 separately as nearly as practicable in the commission's general

- 1 accounting system. The moneys shall be derived from the
- 2 revenues of multistate lottery games.
- 3 (i) The commission, in addition to other games authorized
- 4 by this chapter, shall establish special instant ticket games
- 5 with play areas protected by paper tabs designated for use by
- 6 charitable organizations. The moneys for prizes and for
- 7 operating expenses shall be accounted for separately as nearly
- 8 as practicable in the commission's general accounting system.
- 9 Moneys saved from the revenues of the special instant ticket
- 10 games, by reason of operating efficiencies, shall become other
- 11 revenue of the commission and shall revert to the state general
- 12 fund.
- 13 (j) Except as provided in subsection (d), the commission
- 14 or executive director shall not establish or operate any online
- 15 or electronic keno game or any game played on the Internet.
- 16 (k) The executive director shall print, in a prominent
- 17 location on each lottery ticket or share, a statement that help
- 18 is available if a person has a problem with gambling and a toll-
- 19 free telephone number where problem gambling assistance is
- 20 available.



1	The executive director shall require all licensed agents to
2	post a sign with the statement that help is available if a
3	person has a problem with gambling and the toll-free telephone
4	number at the point of sale as prescribed and supplied by the
5	executive director.
6	§ -5 Disposition of revenue. (a) Not more than
7	eighteen and one-half per cent of the total annual revenues
8	accruing from the sale of lottery tickets or shares and from all
9	other sources, unless otherwise specified, and not more than
10	thirty-five per cent of the total annual revenues from the sale
11	of special instant ticket games authorized under section
12	-4(i) shall be deposited in the state lottery revolving fund
13	established by section -24 to be expended for:
14	(1) The payment of costs incurred in the operation and
15	administration of the lottery, including the expenses
16	of the commission and the costs resulting from any
17	contract or contracts entered into for consulting or
18	operational services;
19	(2) Independent audits, which shall be performed annually
20	in addition to the audits required by section -27;

1	(3)	Incentive	programs	for	lottery	sales	agents	and
2		lottery e	mployees;					

- Payment of compensation to licensed sales agents 3 (4)necessary to provide for the adequate availability of 4 lottery tickets or services to prospective buyers and 5 for the convenience of the public. Except as 6 otherwise provided in this subsection, compensation of 7 licensed sales agents shall be at least five and one-8 half per cent but not more than eight per cent of the 9 10 price of each lottery ticket or share that a retail 11 sales agent sells in instant games and online games, less the price of any lottery tickets or shares that 12 13 are voided;
 - (5) The payment of reasonable fees to redemption agents as authorized by section -22;
 - (6) The purchase or lease of lottery equipment, lottery tickets, and materials; and
- 18 (7) Compensation of a licensed sales agent who is
 19 designated as a charitable organization shall be
 20 twenty per cent of the price of each lottery ticket
 21 from a special instant ticket game authorized under

1	section -4(1) and shall be an offset against the
2	sale of the lottery ticket.
3	(b) Not less than fifty per cent of the total annual
4	revenues accruing from the sale of lottery tickets or shares
5	shall be deposited in the state lottery prize revolving fund
6	established by section -26 for payment of prizes to the
7	holders of winning lottery tickets or shares or for the purposes
8	provided for in section -21.
9	(c) All other revenues accruing from the sale of lottery
10	tickets or shares in online games or instant games shall be
11	deposited in the state lottery revolving fund established by
12	section -24 to be used as specified by section -25.
13	(d) Except for moneys for prizes expended as provided in
14	section -4(g), revenues expended under subsection (a) shall
15	be subject to legislative appropriation.
16	§ -6 Powers and duties of the executive director. In
17	addition to any other powers and duties authorized in this
18	chapter, the executive director shall:
19	(1) Supervise and administer the operation of the lottery
20	in accordance with this chapter and the rules adopted
21	under this chapter, subject to the continuous duty to

1		take into account the particularly sensitive and
2		responsible nature of the commission's functions;
3	(2)	Enforce this chapter and the rules adopted under this
4		chapter. The executive director shall receive
5		allegations of any violations of the laws of this
6	ı	State or rules pertaining to the conduct of the
7		lottery;
8	(3)	Pursuant to this chapter and the rules adopted by the
9		commission, license as agents to sell lottery tickets
10		persons that shall best serve the public convenience
11		and promote the sale of lottery tickets or shares;
12	(4)	Hire professional, clerical, technical, and
13		administrative personnel as may be necessary to carry
14		out this chapter. The executive director shall
15		conduct background checks of prospective employees
16		and, in all employment decisions, shall take into
17		account the particularly sensitive and responsible
18		nature of the operation of the state lottery;
19	(5)	Act as secretary and executive officer of the
20		commission;

1	(0)	conter regularly as necessary or desirable and not
2		less than once each quarter with the commission on the
3		operation and administration of the lottery;
4	(7)	Make available for inspection by the commission, upon
5		request, all books, records, files, and other
6		information and documents of the commission;
7	, (8)	Advise the commission and recommend matters as are
8		necessary and advisable to improve the operation and
9		administration of the lottery;
10	(9)	Suspend or revoke any license issued pursuant to this
11		chapter or the rules adopted pursuant to this chapter,
12		subject to appeal to the commission; and
13	(10)	Within thirty days after receiving an allegation of a
14		violation of the laws of this State or rules
15		pertaining to the conduct of the lottery by a licensed
16		agent and evidence substantiating the allegation,
17		determine whether the agent has violated the rules and
18		if a criminal investigation is warranted.
19	S	-7 Monthly reports; annual reports. (a) The
20	executive	director shall submit a monthly report to the
21	commissio	n, the governor, and the legislature. The monthly

1	report shall include the total lottery revenue, prize
2	disbursements, and other expenses for the preceding month.
3	(b) The commission shall submit an annual report to the
4	governor and the legislature not less than twenty days prior to
5	the convening of each regular session. The annual report shall
6	include a full and complete statement of lottery revenues, prize
7	disbursements, and other expenses for the preceding years, and
8	recommendations, including any proposed legislation, that the
9	commission deems necessary or desirable.
10	§ -8 Studies and investigations. (a) The executive
11	director shall conduct an ongoing study and investigation of the
12	lottery to:
13	(1) Ascertain any provisions in this chapter or in its
14	rules through which any abuses in the administration
15	and operation of the lottery or any evasion of this
16	chapter or its rules may arise or be practiced;
17	(2) Formulate recommendations for changes to this chapter
18	(3) Guard against the use of this chapter and the rules a
19	a pretext for organized gambling and crime; and

1	(4) Ensure that this chapter and its rules are in a form
2	and are administered to serve the true purposes of
3	this chapter.
4	(b) The executive director shall conduct an ongoing study
5	and investigation of the operation and the administration of
6	lottery laws in effect in other states or countries, any
7	literature on the subject that may be published or available,
8	any federal laws that may affect the operation of the lottery,
9	and the reaction of residents to existing and potential features
10	of the lottery in order to recommend or effect changes that
11	serve the purposes of this chapter.
12	§ -9 Contracts; limitation; restrictions. (a)
13	Notwithstanding any law to the contrary, the executive director
14	may:
15	(1) Directly solicit bids and contract for the design and
16	operation of the lottery or the purchase of lottery
17	equipment, lottery tickets, and related materials;
18	(2) Contract to effectuate the purposes of this chapter
19	and the rules adopted pursuant to this chapter; and

- 10 (c) The executive director may establish by rule and
 11 collect a fee for a license issued pursuant to this section.
- 12 (d) No license shall be assignable or transferable.
- (e) A licensed agent or licensed agent's employee may sell
- 14 lottery tickets or shares only on the premises stated in the
- 15 license of the agent.
- 16 (f) The executive director may purchase a blanket bond17 covering the activities of licensed agents.
- (g) A licensed agent shall display the licensed agent's
- 19 license or a copy of the license conspicuously in accordance
- 20 with the rules adopted by the executive director.

- (h) If a licensed agent sells lottery tickets or shares on
- 2 leased premises and all or part of the agent's rental payments
- 3 are based on the total volume of sales made at the premises, the
- 4 compensation paid by the commission to the agent for the sale of
- 5 lottery tickets and shares shall be the amount of the sale for
- 6 the purposes of determining the agent's rental payments. This
- 7 subsection shall not apply if the lease agreement expressly
- 8 provides that the total volume of sales made at the premises

- 10 (i) The commission shall adopt rules to establish
- 11 penalties for a licensed agent who violates section -16 or
- 12 -17; provided that the penalties for a subsequent violation
- 13 within any twelve-month period shall be more severe than the

- 15 (j) The executive director shall not require a licensed
- 16 agent, as a condition of securing or continuing to hold a
- 17 license, to sell lottery tickets or shares to the public or to
- 18 sell lottery tickets or shares through or by the use of a self-
- 19 service vending machine at the licensed agent's premises.
- 20 (k) For the purposes of this section, acts or omissions of
- 21 an employee at the premises of a licensed agent or sales of
