HOUSE CONCURRENT RESOLUTION

DECLARING A CLIMATE EMERGENCY AND REQUESTING STATEWIDE COLLABORATION TOWARD AN IMMEDIATE JUST TRANSITION AND EMERGENCY MOBILIZATION EFFORT TO RESTORE A SAFE CLIMATE.

1 WHEREAS, global warming has now raised the air temperature 2 about one degree Celsius, and scientists have documented that 3 this extra heat is already having a dramatic impact on the 4 environment: larger and stronger hurricanes, increased drought 5 and flooding, shifting rain patterns, more and larger wildfires, 6 a hotter and more acidic ocean, and damaged ecosystems, both 7 marine and terrestrial, across the planet; and 8

9 WHEREAS, in April 2016 world leaders recognized the urgent 10 need to combat climate change by signing the Paris Agreement, 11 agreeing to keep global warming "well below 2°C (3.6°F) above 12 pre-industrial levels" and to "pursue efforts to limit the 13 temperature increase to 1.5°C (2.7°F)"; and

15 WHEREAS, in 2017 over fifteen thousand scientists published a "Warning to Humanity" declaring that greenhouse gases produced 16 from human activities have "pushed Earth's ecosystems to their 17 breaking point", and in 2019 over eleven thousand scientists 18 declared unequivocally that "planet Earth is facing a climate 19 emergency" and it will now take "an immense increase of scale in 20 21 endeavors to conserve our biosphere" to avoid untold suffering; 22 and

WHEREAS, in the absence of action to reduce greenhouse gas emissions, reports indicate that warming is likely to accelerate in the next decade and reach 1.5 degrees Celsius by 2030, ten years earlier than projected by the 2014 Intergovernmental Panel on Climate Change (IPCC), and 2 degrees Celsius by 2045; and

WHEREAS, based upon the scientific information and 1 2 expertise available, Hawaii is in danger of disaster occurrences as a result of the effects of global warming, thereby 3 endangering the health, safety, and welfare of the people, 4 5 warranting preemptive and protective action; and 6 7 WHEREAS, the Hawaii State Constitution adopts the public trust doctrine for the benefit of the people and the right of 8 each person to a clean and healthful environment; and 9 10 11 WHEREAS, 1,330 jurisdictions in twenty-six countries have already declared a climate emergency as of January 28, 2020; 12 now, therefore, 13 14 BE IT RESOLVED by the House of Representatives of the 15 Thirtieth Legislature of the State of Hawaii, Regular Session of 16 2020, the Senate concurring, that this body acknowledges that an 17 existential climate emergency threatens humanity and the natural 18 world and declares a climate emergency and requests statewide 19 collaboration toward an immediate just transition and emergency 20 mobilization effort to restore a safe climate; and 21 22 23 BE IT FURTHER RESOLVED that these climate mitigation and 24 adaptation efforts mobilize at the necessary scale and speed: 25 A statewide commitment to a just transition toward a 26 (1)decarbonized economy that invests in and ensures clean 27 28 energy, quality jobs, and a statewide commitment to a climate emergency mobilization effort to reverse the 29 30 climate crisis, which, with appropriate financial and regulatory assistance from state authorities, will 31 transform the economy at emergency speed to zero 32 emissions and meet the emission targets as set forth 33 by the IPCC report to limit warming to 1.5 degrees 34 Celsius; 35 36 A prohibition against any further public or private 37 (2) investment or subsidies in projects that will make the 38 climate emergency worse, such as coal, oil, gas, and 39 tree-burning projects, and redirecting and channeling 40 subsidies toward low climate impact energy projects 41 and workforce retraining; 42

Facilitation of investments in beneficial projects and 1 (3) infrastructure such as zero emissions energy; electric 2 vehicles, including clean fleet transitions for the 3 State and counties; energy efficiency; reforestation; 4 afforestation; climate-smart agriculture; and climate-5 friendly land use; and 6 7 8 (4)Organization and tracking of a time-phased implementation plan, assigning state government 9 agencies responsibilities and timetables and 10 establishing task dependencies between departments, 11 with a priority to plan and coordinate, at a statewide 12 13 level, all climate and resilience responses, including emergency mitigation of climate change effects, 14 resilience, adaptation, engagement, education, 15 advocacy, and research and development programs, 16 beginning with a robust climate emergency public 17 education and stakeholder outreach process, and 18 including a Climate Impacts section to all 19 departmental reports utilizing lifecycle greenhouse 20 gas analysis that provides meaningful information on 21 how proposed actions will impact greenhouse gas 22 reduction efforts: and 23 24 BE IT FURTHER RESOLVED that the State commits to statewide 25 action that is rooted in equity, self-determination, culture, 26 tradition, and the belief that people locally and around the 27 world have the right to clean, healthy, and adequate air, water, 28 land, food, education, and shelter; and 29 30 BE IT FURTHER RESOLVED that nothing in this measure 31 constitutes a declaration of an emergency for purposes of any 32 act authorizing the exercise, during the period of a state 33 emergency or other type of declared emergency, of any special or 34 35 extraordinary power; and 36 BE IT FURTHER RESOLVED that certified copies of this 37 Concurrent Resolution be transmitted to the Governor; Attorney 38 General; Chairperson of the Board of Land and Natural Resources, 39 who also serves as Co-Chairperson of the Hawaii Climate Change 40

Mitigation and Adaptation Commission; Director of the Office of

Planning, who also serves as Chairperson of the Greenhouse Gas
