## HOUSE CONCURRENT RESOLUTION

URGING THE FEDERAL AVIATION ADMINISTRATION TO ADVOCATE THE ENACTMENT OF THE FEDERAL LEGISLATION ESTABLISHING THE "SAFE AND QUIET SKIES ACT OF 2019" AND VIGOROUSLY ENFORCE IT WHEN IT BECOMES LAW.

1 2	WHEREAS, communities throughout the State have complained about the noise and safety hazards posed by commercial air
3 4	tours; and
5 6	WHEREAS, in response to the challenges posed by commercial
7	air tours, neighborhood boards on Oahu have passed resolutions that seek safety and peace for residents; and
8 9	WHEREAS, state efforts to prevent commercial air tour
10 11	noise, limit tour flight paths, or ensure the safe operation of tour aircraft are usually thwarted by concerns that those state-
12 13	level restrictions would be preempted by federal law; and
14 15	WHEREAS, the Federal Aviation Administration has the authority to impose and enforce regulations on the operation of
16 17	aircraft; and
18 19	WHEREAS, according to the National Transportation Safety
20	Board, fifty-one passengers and pilots have died in commercial helicopter collisions in the State since 2000; and
21 22	WHEREAS, in a letter to the National Transportation Safety
23 24 25	Board dated February 25, 2020, Senator Brian Schatz of Hawaii cited recent aircraft fatalities and stated that 2019
25 26 27	"represented the deadliest year in Hawaii aviation in [twenty- eight] years", opined that the Federal Aviation Administration had a "disturbing trend of ineffective oversight and
28	insufficient safety regulations", and called for the board to

1 relating to commercial aircraft operators, instead of 2 regulations relating to non-commercial aircraft 3 operators; and 4 WHEREAS, H.R. 4547 could be a vehicle for the Federal 5 Aviation Administration to improve its operations, serve the 6 7 people of Hawaii, and build faith in the agency's regulatory efforts; now, therefore, 8 9 10 BE IT RESOLVED by the House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 11 2020, the Senate concurring, that the Federal Aviation 12 Administration is urged to review H.R. 4547, advocate for the 13 legislation's enactment, and vigorously enforce the Safe and 14 Quiet Skies Act of 2019 when it becomes law; and 15 16 17 BE IT FURTHER RESOLVED that the Federal Aviation 18 Administration is urged to communicate with members of Hawaii's 19 congressional delegation regarding H.R. 4547; and 20 21 BE IT FURTHER RESOLVED that the Federal Aviation Administration is urged to address any issue raised by any 22 23 roundtable discussion convened by the National Transportation 24 Safety Board and discuss how H.R. 4547 may make commercial air 25 tours safer; and 26 27 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Administrator of the 28 Federal Aviation Administration; Chairman of the National 29 Transportation Safety Board; Majority Leader of the United 30 31 States Senate; Speaker of the United States House of Representatives; members of Hawaii's congressional delegation; 32 and Director of Transportation, State of Hawaii. 33 34 35 36 OFFERED BY:
