## HOUSE RESOLUTION

AMENDING THE RULES OF THE HOUSE OF REPRESENTATIVES TO TEMPORARILY ALLOW REMOTE PARTICIPATION.

WHEREAS, an ongoing global respiratory disease pandemic 1 named "coronavirus disease 2019", or COVID-19 has made a 2 dramatic impact on the health, safety, and economic well-being 3 of the State and continues to pose a serious health, safety, and 4 economic risk to Hawaii; and 5 6 7 WHEREAS, in a matter of months, the COVID-19 pandemic swiftly spread around the world, including the United States, 8 and consequently put the health, safety, and welfare of the 9 people of Hawaii at risk; and 10 11 WHEREAS, as of June 18, 2020, there have been seventeen 12 deaths and seven hundred sixty-two cases of COVID-19 in the 13 State alone; and 14 15 WHEREAS, state and county officials have implemented 16 several emergency measures to reduce the spread of COVID-19, 17 including stay-at-home orders, mandated social distancing 18 measures, a mandatory fourteen-day quarantine for travelers, and 19 the closure of all nonessential businesses; and 20 21 WHEREAS, in response to the Centers for Disease Control and 22 Prevention's social distancing recommendations to diminish the 23 risk of spreading COVID-19, the Legislature recessed the Regular 24 Session of 2020, beginning March 17, 2020; and 25 26 WHEREAS, since March 23, 2020, the State Capitol has been 27 closed to the public; and 28 29 WHEREAS, after nearly two months in an extended recess, the 30 Legislature briefly reconvened the Regular Session of 2020 on 31 May 11, 2020, to address a number of critical issues, including 32

the State's projected \$1,000,000,000 budget shortfall and the 1 receipt of federal economic and financial relief under the 2 Coronavirus Aid, Relief, and Economic Security Act, Public Law 3 116-136, and subsequent federal stimulus measures; and 4 5 WHEREAS, the Legislature passed several measures before it 6 recessed for a second extended period beginning May 22, 2020; 7 and 8 9 WHEREAS, the Legislature has not yet adjourned the Regular 10 Session of 2020 sine die and stands ready to reconvene at a 11 12 moment's notice; and 13 WHEREAS, however, in addition to its concerns about social 14 distancing, the House recognizes that nearly one-third of its 15 representatives live on a neighbor island and must travel to 16 Oahu when the Legislature is in session; and 17 18 WHEREAS, several legislative chambers, including the Hawaii 19 State Senate, have amended their legislative operations to allow 20 remote participation or voting in response to health and safety 21 22 concerns during the COVID-19 pandemic; and 23 WHEREAS, the House Select Committee on COVID-19 Economic 24 and Financial Preparedness continues to hold and successfully 25 broadcast meetings throughout the COVID-19 pandemic by utilizing 26 remote videoconferencing technology; and 27 28 WHEREAS, Article III, Section 12 of the Constitution of the 29 State of Hawaii specifically grants to each chamber the power to 30 determine the rules of its proceedings; now, therefore, 31 32 BE IT RESOLVED by the House of Representatives of the 33 Thirtieth Legislature of the State of Hawaii, Regular Session of 34 2020, that the House of Representatives hereby amends the Rules 35 of the House of Representatives by adding a new part XIV to read 36 as follows: 37
