## A BILL FOR AN ACT

RELATING TO INTOXICATING LIQUOR.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that under the current
3	definition of "cooler beverage", the relevant tax rate is only
4	applicable to wine-based or beer-based beverages, while
5	beverages that are spirits-based are taxed as distilled spirits.
6	Consequently, if a local distiller wants to make a "cooler
7	beverage" that contains one ounce of distilled spirits and
8	eleven ounces of another liquid, the beverage is taxed as if it
9	consists entirely of alcohol. Although several companies on the
10	mainland export small volumes of ready-to-drink cocktails in
11	cans or bottles, none of the growing number of local
12	distilleries offer this option. The disparate tax treatment may
13	be the primary reason.
14	The purpose of this part is to amend the definition of
15	"cooler beverage" to include spirits-based beverages, to
16	encourage local distilleries to produce ready-to-drink
. 17	cocktails.

2	amended by	y amending the definition of "cooler beverage" to read
3	as follow	s:

6		cent added natural or artificial blending material,
7		such as fruit juices, flavors, flavorings, or

9		colorings, or preservatives, and that contains less
10		than seven per cent of alcohol by volume; [or]
11	(2)	Malt beverage cooler containing beer and added natural
12		or artificial blending material, such as fruit juices,
13		flavors, flavorings, colorings, or preservatives, and
14		that contains less than seven per cent of alcohol by
15		volume[-]; or
16	(3)	Spirit beverage cooler containing distilled spirits
17		and added natural or artificial blending material,
18		such as fruit juices, flavors, flavorings, colorings,
19		or preservatives, and that contains less than twelve
20		per cent of alcohol by volume."

- 2 SECTION 3. The legislature finds that the current taxation
- 3 scheme on beer is confusing and burdensome. A lower tax rate is
- 4 imposed on draft beer, which is statutorily defined as beer in
- 5 an individual container of seven gallons or larger. However,
- 6 the container size requirement does not align with industry
- 7 practices. Many beer sellers, including many local small
- 8 brewers, dispense what is commonly referred to as draft beer
- 9 from containers smaller than seven gallons.
- 10 The legislature further finds that the higher tax rate
- 11 applied to non-draft beer discourages the business of local
- 12 brewers, who may be unable to distribute in larger containers or
- 13 who may benefit from individually packaging their beer.
- 14 The purpose of this part is to eliminate the tax disparity
- 15 between beer dispensed from containers of seven gallons or more
- 16 and beer in all other packaging.
- 17 SECTION 4. Section 244D-1, Hawaii Revised Statutes, is
- 18 amended as follows:
- 1. By amending the definition of "distilled spirits" to
- **20** read:

1 ""Distilled spirits" means an alcoholic beverage obtained 2 by the distillation of fermented agricultural products, and 3 includes alcohol for beverage use, spirits of wine, whiskey, rum, brandy, and gin, including all dilutions and mixtures 4 5 thereof, but does not include beer, [draft beer,] cooler 6 beverage, or wine." 2. By amending the definition of "liquor" to read: 7 ""Liquor" has the same meaning as set forth in section 8 9 281-1 and includes alcohol, and the liquor categories: beer, **10** [draft beer,] cooler beverage, distilled spirits, and wine." 11 3. By repealing the definition of "draft beer". 12 [""Draft beer" means beer in an individual container of seven gallons or more."] 13 14 SECTION 5. Section 244D-4, Hawaii Revised Statutes, is 15 amended by amending subsection (a) to read as follows: 16 "(a) Every person who sells or uses any liquor in the 17 State not taxable under this chapter, in respect of the 18 transaction by which the person or the person's vendor acquired 19 the liquor, shall pay a gallonage tax which is hereby imposed at

the following rates for the various liquor categories defined in

section 244D-1:
