## A BILL FOR AN ACT

RELATING TO YOUTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

### PART I

2 SECTION 1. The National Center for Housing and Child 3 Welfare reports that there are between one million and seven 4 million homeless youth who have run away or have been asked to 5 leave their homes. According to the National Runaway 6 Switchboard, it is estimated that on any given night, there are 7 approximately 1.3 million homeless youth living unsupervised on 8 the streets, in abandoned buildings, with friends, or with 9 strangers. Homeless youth lack parental, foster, or 10 institutional care and are thus prone to be at a higher risk for 11 physical abuse, sexual exploitation, mental health disabilities, 12 substance abuse, and death.

13 The legislature finds that Hawaii is not immune to the 14 seriousness and prevalence of youth homelessness. A 2016 15 National Conference of State Legislatures article, "Homeless and 16 Runaway Youth," indicates that studies have shown that forty-six 17 per cent of runaway and homeless youth reported being physically

1 abused, thirty-eight per cent reported being emotionally abused,
2 and seventeen per cent reported being forced into unwanted
3 sexual activity by a family or household member. Furthermore,
4 seventy-five per cent of homeless or runaway youth have dropped
5 out or will drop out of school. The legislature recognizes the
6 necessity of establishing safe places that offer shelter,
7 programs, and support to at-risk youth.

8 The purpose of this part is to:

9 (1) Require the office of youth services to coordinate a 10 three-year safe places for youth pilot program, which 11 will coordinate a network of safe places that youth 12 can access for safety and where youth can obtain 13 advice, quidance, programs, and services; and (2) Establish and appropriate funds for a safe places for 14 15 youth pilot program coordinator position and 16 residential options for the pilot program. SECTION 2. (a) The office of youth services shall 17 18 coordinate a three-year safe places for youth pilot program in 19 partnership with private organizations. The primary objective 20 of the pilot program shall be to coordinate a network of safe 21 places that youth can access for safety and where they can

1 obtain advice, guidance, programs, and services. All youth 2 shall be eligible for services at the safe places. The 3 requirements to consent to emergency shelter and related 4 services, as set forth in section 346-17.6, Hawaii Revised 5 Statutes, shall apply to services provided under the safe places 6 for youth pilot program. 7 (b) There is established the position of a safe places for 8 youth pilot program coordinator. The coordinator shall: 9 (1)Coordinate the safe places for youth network; 10 Partner with an entity to maintain an updated listing (2) 11 of safe places statewide; 12 (3) Provide ongoing training for organizations designated 13 as safe places for youth, including training in 14 emergency response and trauma; 15 Partner with the department of education, state (4) 16 student council, peer education programs, private 17 schools, and other youth services organizations to 18 build awareness of the safe places for youth network; 19 and 20 Convene an annual meeting of safe places for youth (5)

1 (e) The office of youth services shall submit a report of 2 its findings and recommendations, including any proposed 3 legislation, to the legislature no later than twenty days prior 4 to the convening of the regular sessions of 2021 and 2022. The 5 reports shall include a recommendation on whether the pilot 6 program should be continued, modified, or terminated. 7 (f) The safe places for youth pilot program shall cease to 8 exist on June 30, 2022. 9 (q) For the purposes of this section: 10 "Safe places" means physical and virtual places of safety 11 for youth. 12 "Youth" means any person less than eighteen years of age. 13 SECTION 3. There is appropriated out of the general 14 revenues of the State of Hawaii the sum of \$ or so 15 much thereof as may be necessary for fiscal year 2019-2020 and 16 the same sum or so much thereof as may be necessary for fiscal 17 year 2020-2021 for one full-time equivalent (1.0 FTE) safe 18 places for youth pilot program coordinator position and for 19 residential options for the pilot program. 20 The sums appropriated shall be expended by the department 21 of human services for the purposes of this part.



1 PART II 2 SECTION 4. The legislature finds that "status offenses", 3 conduct that would not be crimes except if committed by a minor, 4 such as truancy, are linked to a strong need for services to 5 address a myriad of family and social causes in the young 6 person's lives. The general response to status offenders is 7 involvement with the criminal justice system, even though 8 research has shown that incarceration and other forms of secure 9 detention have a severe negative impact on youth and do not 10 resolve the issues that led to the offense. Innovative programs 11 have and continue to be developed to better address status 12 offense conduct and divert youth from entering the criminal 13 justice system. 14 The purpose of this part is to: 15 (1) Require the office of youth services to examine and 16 report on options to reduce the use of status offense 17 laws and increase the use of diversion programs and 18 services for youth involved in status offense-type 19 conduct; and 20 (2) Appropriate funds for the office of youth services to

implement, through a contract with a community

services provider, a status offense diversion program
 for three years.

3 SECTION 5. The office of youth services shall examine 4 options to reduce the use of status offense laws and increase 5 the use of diversion programs and services for youth involved in 6 status offense-type conduct. The office of youth services shall 7 submit a report of its findings and recommendations, including 8 any proposed legislation, to the legislature no later than 9 twenty days prior to the convening of the regular sessions of 10 2021 and 2022.

SECTION 6. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2019-2020 and the same sum or so much thereof as may be necessary for fiscal year 2020-2021 for the office of youth services to implement, through a contract with a community services provider, a status offense diversion program.

18 The sums appropriated shall be expended by the department 19 of human services for the purposes of this Act.

SECTION 7. This Act shall take effect on July 1, 2019.
