A BILL FOR AN ACT

RELATING TO CLINICAL VICTIM SUPPORT SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that sexual violence and
- 2 abuse are extremely prevalent in the United States. One in six
- 3 women and one in thirty-three men have experienced an attempted
- 4 or completed rape in their lifetimes, while one in four girls
- 5 and one in six boys will be sexually abused before they turn
- 6 eighteen. According to the federal Centers for Disease Control
- 7 and Prevention, an estimated 43.9 per cent of women and 23.4 per
- 8 cent of men have experienced forms of sexual violence other than
- 9 rape within their lifetimes.
- 10 The legislature further finds that sexual violence and
- 11 abuse can have severe and lasting emotional and mental health
- 12 impacts on victims. Victims of sexual assault during adulthood
- 13 suffer post-traumatic stress disorder at a rate between thirty
- 14 to sixty-five per cent, as well as elevated rates of depressive
- 15 disorders, parasuicidal behaviors, and substance use disorders.
- 16 Victims of sexual abuse during childhood face numerous
- 17 psychological challenges at rates higher than people who have

- 1 not experienced sexual abuse, including being three to five
- 2 times more likely to be diagnosed with post-traumatic stress
- 3 disorder; having fifty-two per cent higher rates of lifetime
- 4 depression; and experiencing increased rates of suicide and of
- 5 self-harming behaviors, alcohol use, eating disorders, and
- 6 disruptions to developmental processes that lead to personality
- 7 disorders. Consequently, many victims of sexual violence and
- 8 abuse represent mental health cases that require clinical victim
- 9 support services by licensed mental health providers, in
- 10 addition to psychotherapy, to effectively manage mental
- 11 disorders related to sexual violence and abuse.
- 12 The legislature also finds that it can be difficult for
- 13 victims of sexual violence and abuse to obtain appropriate
- 14 mental health services due to the limited availability of
- 15 licensed mental health providers who are able to take on
- 16 potentially complex mental health cases. Clinical victim
- 17 support services, which are required for treatment of mental
- 18 disorders caused, in whole or in part, by sexual violence and
- 19 abuse, are not generally covered by health insurers. This is a
- 20 barrier to sufficient provider availability, as clinical victim

- 1 support services are often an unreimbursed expense that
- 2 discourages providers from accepting potentially complex cases.
- 3 The legislature additionally finds that under existing law,
- 4 health insurance policies offered by health insurers, mutual
- 5 benefit societies, fraternal benefit societies, and health
- 6 maintenance organizations are required to provide coverage for
- 7 mental health outpatient services. Clinical victim support
- 8 services are routinely and normally provided by licensed mental
- 9 health providers to survivors of sexual violence and abuse.
- 10 Since a strong argument exists that these types of services fall
- 11 within the existing definition of "mental health outpatient
- 12 services", coverage for clinical victim support services should
- 13 already have been a covered mental health outpatient services
- 14 benefit under chapter 431M, Hawaii Revised Statutes, and would
- 15 not be considered a new covered benefit. Therefore, section
- 16 23-51, Hawaii Revised Statutes, which requires an impact
- 17 assessment report by the auditor prior to any new legislatively-
- 18 mandated health insurance coverage, does not apply.
- 19 The purpose of this Act is to improve mental health service
- 20 availability for victims of sexual violence and abuse by
- 21 clarifying that clinical victim support services for victims of

- 1 sexual violence and abuse are a mental health outpatient
- 2 services benefit required to be covered under health insurance
- 3 policies offered by health insurers, mutual benefit societies,
- 4 fraternal benefit societies, and health maintenance
- 5 organizations.
- 6 SECTION 2. Section 431M-1, Hawaii Revised Statutes, is
- 7 amended by adding two new definitions to be appropriately
- 8 inserted and to read as follows:
- 9 "Clinical victim support services" means a professional
- 10 intervention conducted by a licensed mental health provider to
- 11 identify needs and assist in obtaining coordinated, appropriate
- 12 services and resources for a victim of sexual violence and abuse
- 13 to curtail or prevent the progression and worsening of mental
- 14 disorders and associated functional impairments caused, in whole
- 15 or in part, by the sexual violence and abuse. "Clinical victim
- 16 support services includes:
- 17 (1) Coordinating with other health care providers, such as
- primary care physicians, behavioral and mental health
- care providers, and hospitals;
- 20 (2) Assisting victims of sexual violence and abuse in
- obtaining appropriate government entitlements, access,

10	SECTION 3. Section 431M-2, Hawaii Revised Statutes, is		
11	amended by amending subsection (a) to read as follows:		
12	"(a)	All individual and group policies of accident and	
13	health or sickness insurance [policies] issued in this State,		
14	individual or group hospital or medical service plan contracts,		
15	and nonprofit mutual benefit society, fraternal benefit society,		
16	and health maintenance organization health plan contracts shall		
17	include wit	thin their hospital and medical coverage the benefits	
18	of alcohol	use disorder, substance use disorder, and mental	
19	health trea	atment services, including services for alcohol	
20	dependence and drug dependence[7] and clinical victim support		
21	services fo	or victims of sexual violence and abuse, except that	

- 1 this section shall not apply to insurance policies that are
- 2 issued solely for single diseases, or otherwise limited,
- 3 specialized coverage."
- 4 SECTION 4. Section 431M-4, Hawaii Revised Statutes, is
- 5 amended by amending subsection (b) to read as follows:
- 6 "(b) Mental illness benefits.
- Covered benefits for mental health services set forth 7 (1)8 in this subsection shall be limited to coverage for 9 diagnosis and treatment of mental disorders. All 10 mental health services shall be provided under an 11 individualized treatment plan approved by a physician, 12 psychologist, licensed clinical social worker, 13 licensed marriage and family therapist, licensed mental health counselor, advanced practice registered 14 15 nurse, or licensed dietitian treating eating 16 disorders, and must be reasonably expected to improve 17 the patient's condition. An individualized treatment 18 plan approved by a licensed clinical social worker, 19 licensed marriage and family therapist, licensed 20 mental health counselor, advanced practice registered

nurse, or a licensed dietitian treating eating

1		disorders, for a patient aiready under the care or
2		treatment of a physician or psychologist shall be done
3		in consultation with the physician or psychologist;
4	(2)	In-hospital and nonhospital residential mental health
5		services as a covered benefit under this chapter shall
6		be provided in a hospital or a nonhospital residential
7		facility. The services to be covered shall include
8		those services required for licensure and
9		accreditation;
10	(3)	Mental health partial hospitalization as a covered
11		benefit under this chapter shall be provided by a
12		hospital or a mental health outpatient facility. The
13		services to be covered under this paragraph shall
14		include those services required for licensure and
15		accreditation; and
16	(4)	Mental health outpatient services, including clinical
17		victim support services, shall be a covered benefit
18		under this chapter."
19	SECT	ION 5. Section 23-51, Hawaii Revised Statutes, shall
20	not apply	to this Act

- 1 SECTION 6. Notwithstanding any other law to the contrary,
- 2 the coverage and reimbursement for clinical victim support
- 3 services for victims of sexual violence and abuse required under
- 4 sections 3 and 4 of this Act shall also apply to all health
- 5 benefit plans under chapter 87A, Hawaii Revised Statutes,
- 6 issued, renewed, modified, altered, or amended on or after the
- 7 effective date of this Act.
- 8 SECTION 7. Statutory material to be repealed is bracketed
- 9 and stricken. New statutory material is underscored.
- 10 SECTION 8. This Act shall take effect on July 1, 2050.
