A BILL FOR AN ACT

RELATING TO HOMELESS INDIVIDUALS WITH SEVERE MENTAL ILLNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State has a gap
- 2 in services for homeless individuals with severe mental illness
- 3 or severe co-occurring mental illness and substance use
- 4 disorders, as these individuals often cycle between
- 5 homelessness, emergency room treatment, incarceration, and
- 6 hospitalization. Individuals with severe mental illness or
- 7 severe co-occurring mental illness and substance use disorders
- 8 typically become chronically homeless and further burden the
- 9 health care system through excessive use of expensive emergency
- 10 department, inpatient treatment, and crisis services. Due to
- 11 their mental illness, these individuals routinely reject offered
- 12 services and remain on the street, putting themselves at risk of
- 13 further injury and creating a significant burden on the
- 14 communities where they reside.
- 15 The purpose of this Act is to require the department of
- 16 human services to establish a task force to determine specific
- 17 implementation requirements necessary to establish a pilot

- 1 program to provide shelter and mental health treatment for
- 2 homeless individuals with severe mental illness or severe co-
- 3 occurring mental illness and substance use disorders who are
- 4 subject to court-ordered guardianship or assisted community
- 5 treatment orders.
- 6 SECTION 2. (a) There is established within the department
- 7 of human services the task force on chronically homeless
- 8 individuals with severe mental illness or substance use
- 9 disorders. Co-chaired by the directors of the department of
- 10 human services and department of health, the task force shall
- 11 determine specific implementation requirements necessary to
- 12 establish a pilot program intended to procure the services of a
- 13 service provider to operate a shelter and provide mental health
- 14 treatment for homeless individuals with severe mental illness or
- 15 severe co-occurring mental illness and substance use disorders
- 16 who are subject to court-ordered guardianship or assisted
- 17 community treatment orders.
- 18 (b) The task force shall consider specific implementation
- 19 concerns and any procedural, legal, or other requirements
- 20 necessary for a pilot project, including but not limited to:

3		specialized levels of treatment, coordination of care,
4		and compliance with all regulatory and licensing
5		requirements;
6	(2)	Developing procedures to address the safety of clients
7		and staff involved with the pilot program; and
8	(3)	Ensuring that all legal requirements are met when
9		recommending assisted community treatment for an
10		individual under court-ordered guardianship or an
11		assisted community treatment order, when the
12		individual will not voluntarily participate in
13		treatment.
14	(c)	The following individuals shall serve as members of
15	the task	force:
16	(1)	The chair of the senate committee on human services,
17		or a member designated by the president of the senate;
18	(2)	The chair of the house committee on human services and
19		homelessness, or a member designated by the speaker of
20		the house of representatives;
21	(3)	The governor's coordinator on homelessness;

1	(4)	The director of numan services, or the director's
2		designee;
3	(5)	A representative from the med-QUEST division of the
4		department of human services;
5	(6)	A representative from the homeless programs office of
6		the department of human services;
7	(7)	The director of health, or the director's designee;
8	(8)	A representative from the adult mental health division
9		of the department of health;
10	(9)	A representative from the office of health care
11	·	assurance of the department of health;
12	(10)	A representative from the department of the attorney
13		general, to be designated by the attorney general;
14	(11)	A representative from the Hawaii state judiciary; and
15	(12)	A representative from a mental health advocacy group.
16	The	department of human services may recommend additional
17	members w	ith appropriate specialized expertise to the task
18	force.	
19	(d)	For the purposes of facilitating the work, necessary
20	investiga	tion, and to promote decision-making:

1	(1)	The task force members may work together, investigate
2		matters, and make preliminary decisions without regard
3		to provisions of section 92-2.5, Hawaii Revised
4		Statutes; provided that any decisions are:
5		(A) Included in the meeting notice of the task force;
6		and
7		(B) Subject to further review and comment by the task
8		force members and members of the public who are
9		present at a duly noticed meeting of the task
· 10		force; and
11		provided further that the exemption from section 92-
12		2.5 shall cease on January 1, 2020; and
13	(2)	A majority of task force members or their designees
14		present at a duly noticed meeting of the task force
15		shall constitute a quorum of the task force as
16		provided by section 92-15, Hawaii Revised Statutes.
17	(e)	The task force shall submit a report of its findings
18	and recom	mendations, including any proposed legislation, no
19	later tha	an thirty days prior to the convening of the regular
20	geggion o	of 2020

- 1 (f) The task force shall cease to exist on June 30, 2021,
- 2 unless extended by an act of the legislature.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so much
- 5 thereof as may be necessary for fiscal year 2019-2020 and the
- 6 same sum or so much thereof as may be necessary for fiscal year
- 7 2020-2021 for the purposes of this Act.
- 8 The sums appropriated shall be expended by the department
- 9 of human services for the purposes of this Act.
- 10 .SECTION 4. This Act shall take effect on July 1, 2030.
