industry, trade, or professional association, only the 1 association is the employer of the lobbyist. 2 The March 31 report shall cover the period from 3 (b) January 1 through the last day of February. The May 31 report 4 shall cover the period from March 1 through April 30. The 5 January 31 report shall cover the period from May 1 through 6 December 31 of the previous year. In a general election year, 7 the report filed on the second Friday in August shall cover the 8 period from May 1 through July 31; the report filed on the first 9 Monday in November shall cover the period from August 1 through 10 October 31; and the January 31 report shall cover the period 11 from November 1 through December 31 of the previous year. The 12 report to be filed within thirty days after adjournment sine die 13 of a special session of the legislature shall: 14 Cover the period from May 1 through adjournment sine 15 (1)die of that special session; 16 Be filed only by persons listed in subsection (a) who 17 (2) engage in lobbying activities, or who make 18 expenditures for the purpose of attempting to 19 influence legislative action considered during a 20 21 special session; and

(3) Apply to and include only those expenditures and 1 contributions that relate to legislative action 2 considered during that special session; 3 provided that those expenditures and contributions included in 4 the report need not be included by the person filing the report 5 6 in any subsequent statement of expenditures." SECTION 2. This Act does not affect rights and duties that 7 matured, penalties that were incurred, and proceedings that were 8 9 begun before its effective date. 10 SECTION 3. New statutory material is underscored. SECTION 4. This Act shall take effect upon its approval. 11
