12		operator of a low-speed electric bicycle shall be at	
13		least fifteen years of age."	
14	SECT	TON 2. Section 286-2, Hawaii Revised Statutes, is	
15	amended by amending the definition of "bicycle" to read as

16		including any vehicle generally recognized as a
17		bicycle though equipped with two front or two rear
18		wheels except a toy bicycle[-]; or
19	(2)	A low-speed electric bicycle, as defined under title
20		15 United States Code section 2085; provided that an

1	operator of a low-speed electric bicycle shall be at
2	least fifteen years of age."
