## A BILL FOR AN ACT

RELATING TO OHANA ZONES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 209, Session Laws of Hawaii 2018, is
- 2 amended by amending subsection (b) of section 3 to read as
- 3 follows:
- 4 "(b) The governor shall designate executive branch
- 5 agencies to develop and implement the ohana zones pilot program,
- 6 including an agency with specific expertise in construction
- 7 development and an agency with specific expertise in
- 8 administering homeless services. The governor, through the
- 9 governor's designated agencies, shall determine the number and
- 10 locations of the ohana zones, which shall be situated on public
- 11 lands; provided that the designated agencies shall identify at
- 12 least [three] six sites on Oahu and one site on each of the
- 13 islands of Hawaii, Kauai, and Maui[+]; provided further that the
- 14 designated agencies shall identify at least two sites on each of
- 15 the islands of Hawaii, Kauai, and Maui, if the ohana zones pilot
- 16 program capacity permits."

2	amended by	y amending section 4 as follows:
3	1. I	By amending subsection (b) to read:
4	"(b)	The agencies designated by the governor shall
5	establish	[no later than December 31, 2018,] the following:
6	(1)	The criteria that the agencies will use to evaluate
7		potential ohana zone locations;
8	(2)	A monthly timetable of milestones that the agencies
9		expect to meet in establishing one or more ohana zones
10		over the course of the three-year pilot program;
11	(3)	The specific, measurable, attainable, reasonable, and
12		time-based performance measures that the agencies
13		expect to meet at the end of each fiscal year;
14	(4)	The evaluation criteria and process that the agencies
15		intend to use each year when reviewing the success and
16		sustainability of the ohana zones; and
17	(5)	The monitoring and oversight controls that the
18		agencies will have over the ohana zones to identify,
19		address, and prevent possible fraud, waste, and abuse
20		and ensure compliance with local, state, and federal
21		laws."

11	(3)	Any proposed changes that need to be made to the
12		performance measures used to assess the achievement of
13		program goals; [and]
14	(4)	An assessment of the impact of the ohana zone model or
15		the homelessness problem in Hawaii[-];
16	(5)	An evaluation of the ohana zones to determine what
17		ultra-low cost modular housing would be best suited
18		for permanent supportive housing; and
19	<u>(6)</u>	An evaluation of the ohana zones to determine whether
20		there are off-the-grid infrastructure technologies

1	that can provide drinking water, electricity, and
2	process sewage, without existing infrastructure.
3	(f) The pilot program shall cease to exist three years
4	from the contract execution date or on June 30, [2021.] 2022,
5	whichever is later."
6	SECTION 3. There is appropriated out of the general
7	revenues of the State of Hawaii the sum of \$500,000 or so much
8	thereof as may be necessary for fiscal year 2019-2020 and the
9	same sum or so much thereof as may be necessary for fiscal year
10	2020-2021 for the ohana zones pilot program, including expenses
11	related to staffing, facility construction, provision of
12	services, and administrative costs.
13	The sums appropriated shall be expended by the department
14	of human services for the purposes of this Act; provided that:
15	(1) The department of human services shall transfer the
16	expenditure authority to designated executive branch
17	departments or agencies within a reasonable time; and
18	(2) A designated executive branch department or agency
19	with expenditure authority may provide a direct grant
20	to a nonprofit organization based in an ohana zone;
21	provided that fifty per cent of the amount over which

1	the department or agency has expenditure authority
2	shall be distributed first to nonprofit organizations
3	based in an ohana zone.
4	SECTION 4. Statutory material to be repealed is bracketed
5	and stricken. New statutory material is underscored.
6	SECTION 5. This Act shall take effect on July 1, 2050.

### Report Title:

DHS; Homelessness; Housing; Ohana Zones Pilot Program; Appropriation

#### Description:

Increases the number of ohana zone sites on Oahu from 3 to 6. Increases the number of ohana zones on the islands of Hawaii, Kauai, and Maui, if the ohana zones pilot program capacity permits. Requires that additional information be included in the reports submitted no later than 20 days prior to the convening of the regular sessions of 2020 and 2021. Provides additional time for the implementation of the ohana zones pilot program. Appropriates funds to the Department of Human Services for the ohana zones pilot program. Effective 7/1/2050. (SD2)
