BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAI'I:

1	SECT	ION 1. Section 707-702, Hawaii Revised Statutes, is
2	amended by	y amending subsection (1) to read as follows:
3	"(1)	A person commits the offense of manslaughter if:
4	(a)	The person recklessly causes the death of another
5		person; [or]
6	(b)	The person intentionally causes another person to
7		commit suicide; <u>or</u>
8	<u>(c)</u>	The person knowingly distributes a dangerous drug in
9		any amount and another person dies as a result of
10		ingesting that drug. It shall not be a defense to
11		prosecution under this section that the decedent
12		contributed to the decedent's own death or serious
13		bodily injury by voluntary or involuntary ingestion of
14		the drug. A person who commits this offense shall be
15		held strictly liable for causing such a result.
16		"Dangerous drug" shall have the same meaning as that
17		under section 712-1240. "Distributes" shall have the

1	same meaning as "to distribute" under section 712-

DEPARTMENT: Attorney General

TITLE: A BILL FOR AN ACT RELATING TO MANSLAUGHTER.

PURPOSE: To authorize manslaughter prosecution for drug distribution that results in overdose deaths.

MEANS: Amend section 707-702(1), Hawaii Revised Statutes.

JUSTIFICATION: The opioid epidemic (addiction, overdose, and death resulting from prescription pain meds, heroin, fentanyl, etc.) crippling the nation is starting to reach Hawaii. Currently, a drug dealer cannot be held responsible for causing the death of the end user, as this situation does not fall within Hawaii's statutory framework for homicide. However, approximately 21 other states already have similar a law in place, as does the federal government.

> Impact on the public: This bill is responsive to the opioid epidemic but will cover all dangerous drugs. Victims and their families will have better access to justice in these specific situations. Enhanced criminal penalties for drug distribution will improve public safety.

Impact on the department and other agencies: This bill will give law enforcement another tool in the fight against the opioid epidemic and other dangerous drugs. County prosecutors will be the primary agencies affected. Page 2
