#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 150, Session Laws of Hawaii 2018, is
- 2 amended by amending sections 1 through 3 to read as follows:
- 3 "SECTION 1. The Hawaii housing finance and development
- 4 corporation shall institute proceedings for the condemnation of
- 5 the ground lease for the Front Street Apartments [affordable
- 6 housing project] in Lahaina, Maui pursuant to chapter 101,
- 7 Hawaii Revised Statutes.
- 8 SECTION 2. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$250,000 or so much
- 10 thereof as may be necessary for fiscal year 2018-2019 for an
- 11 appraisal and other preparations for instituting the
- 12 condemnation proceedings under section 1; provided that no funds
- 13 authorized pursuant to this section shall be made available
- 14 unless the county of Maui [provides] makes available dollar-for-
- 15 dollar matching funds.
