A BILL FOR AN ACT

RELATING TO THE NURSING FACILITY SUSTAINABILITY PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the nursing facility
- 2 sustainability program that was established in 2012 has served a
- 3 critical role in strengthening the long-term care system in
- 4 Hawaii. In the seven years since its inception, the nursing
- 5 facility sustainability program has helped long-term care
- 6 facilities treat the most vulnerable patients in the State,
- 7 especially low-income individuals who require these services.
- 8 The program has been carried out in a public-private partnership
- 9 to ensure that patients in Hawaii can access quality, affordable
- 10 care.
- 11 The legislature further finds that, even with this program,
- 12 nursing facilities in the State face major financial challenges.
- 13 These challenges are due in part to inadequate payments from the
- 14 medicaid program that do not cover the actual costs of care.
- 15 Medicaid is jointly financed by the federal and state
- 16 governments by statutory formula; the federal government pays
- 17 between fifty per cent and seventy-four per cent, with
- 18 assistance levels determined by each state's per capita income.

1 States with the lowest per capita income receive higher federal 2 matching rates. Under federal rules, the state share must be public funds that are not federal funds. The legislature finds 3 4 that public funding to help sustain Hawaii's nursing facilities 5 financially may be accessed through a provider fee. The legislature further finds that provider fees exist in 6 7 forty-nine states and the District of Columbia as a means of 8 drawing down federal funds to sustain their medicaid programs 9 due to rising state budget deficits, increasing health care 10 costs, and expanding medicaid enrollment. Provider fees, which 11 are collected from specific categories of health care providers 12 that agree to the fee, may be imposed on nineteen different classes of health care services, including inpatient and 13 14 outpatient hospital and nursing facility services. 15 The legislature additionally finds that, in Hawaii, a **16** provider fee on nursing facilities has resulted in a substantial **17** increase in medicaid payments, without putting additional 18 constraints on the State's budget. The additional federal funds 19 obtained via the fee program authorized by the nursing facility 20 sustainability program have helped to reduce the amount of

losses incurred by long-term care facilities and maintain access

to care for un- or under-insured patients in a timely, effective

1	matter. This helps to ensure the overall sustainability of the
2	healthcare system in the State.
3	The purpose of this Act is to preserve access to health
4	care for medicaid recipients by extending the nursing facility
5	sustainability fee program.

TITLE: A BILL FOR AN ACT RELATING TO THE NURSING

FACILITY SUSTAINABILITY PROGRAM.

PURPOSE: To continue the Nursing Facility

Sustainability Program, established by Act 156, Session Laws of Hawaii 2012, last amended by Act 60 Session Laws of Hawaii 2017, by extending the sunset date of the Act to June 30, 2021, updating the referral dates in the statute, appropriating funding out of the Nursing Facility Sustainability Program Special Fund for fiscal years 2019-2020 and 2020-2021, updating the assessment rates and making technical amendments to ensure that the Special Fund is, through December 31, 2021, exempted from the central service expenses assessment and the administrative expenses assessment under sections 36-27(a) and 36-30(a), Hawaii

Revised Statutes, respectively.

Amend sections 346F-4(c), 346F-5(c), 346F-10, and 346F-13(a), Hawaii Revised Statutes, section 5 of Act 156, Session Laws of Hawaii 2012, as amended by Act 142, Session Laws of Hawaii 2013, Act 124, Session Laws of Hawaii 2014, Act 69, Session Laws of Hawaii 2015, Act 59, Session Laws of Hawaii 2016, Act 60, Session Laws of Hawaii 2017, and section 7 of Act 124, Session Laws of Hawaii 2014, as amended by Act 69, Session Laws of Hawaii 2014, as amended by Act 69, Session Laws of Hawaii 2015, Act 59, Session Laws of Hawaii 2016, and Act 60, Session Laws of Hawaii 2017. Appropriates funds from the Nursing Facility

Act 156, Session Laws of Hawaii 2012, last amended by Act 60, Session Laws of Hawaii 2017, established a Nursing Facility Sustainability Program and the Nursing Facility Sustainability Program Special Fund (the Special Fund). The Special Fund receives moneys from the nursing facility

Sustainability Program Special Fund.

JUSTIFICATION:

MEANS:

sustainability fee, which is used to receive federal Medicaid matching funds, and is used to increase reimbursements to the nursing facilities through capitation payments with a greater benefit to those providing proportionately more services to Medicaid recipients. These additional moneys will increase the sustainability of nursing facilities in Hawaii to continue as a critical part of the safety net as well as to incentivize quality using a pay for performance.

Twelve percent of the revenues from the fees collected is used by the Department to increase and improve services for Medicaid program recipients.

The Nursing Facility Sustainability Program currently will be repealed on June 30, 2019, with funding provisions to be repealed on December 31, 2019.

This bill proposes to extend the Nursing Facility Sustainability Program and the Special Fund for an additional two years.

Technical Amendments:

This bill extends the Nursing Facility Sustainability Program for two years past the repeal date of June 30, 2019, and extends the Special Fund for an additional six months thereafter. Therefore, unless the proposed technical amendments are adopted, the exemptions from the central service expenses and administrative expenses assessments will be lost when paragraphs 36-27(a)(32) and 36-30(a)(26), Hawaii Revised Statutes, are repealed on December 31, 2019, and the Special Fund will then be subject to The DHS estimates that those assessments. the Special Fund would be subject to the central service expenses assessment for the period January 1, 2019 through December 31, 2019, in the amount of at least \$2,500,000, and the administrative expenses assessment

for the same period in the amount of \$500,000.

Impact on the public: Hawaii residents benefit by having more sustainable nursing facilities and, thereby, having increased access to necessary long-term care services. Health care services for low-income, vulnerable residents will be increased and improved.

Impact on the department and other agencies:
The Department of Human Services will
benefit by receiving some additional funds
to support its programs.
