### A BILL FOR AN ACT

RELATING TO THE INTERSTATE WILDLIFE VIOLATOR COMPACT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Interstate Wildlife Violator Compact is a		
2	multistate agreement that promotes enforcement of hunting,		
3	fishing, trapping, and other wildlife related regulations across		
4	jurisdictions. For example, the Interstate Wildlife Violator		
5	Compact could prevent wildlife violators who have lost their		
6	hunting, fishing, trapping, or other wildlife related privileges		
7	in other member states from obtaining a hunting license in		
8	Hawaii. Similarly, persons who have been punished with license		
9	revocation in Hawaii would be unable to avoid this punishment by		
10	engaging in those activities in another state. The Interstate		
11	Wildlife Violator Compact also establishes a process by which		
12	nonresident wildlife law violators can be treated as state		
13	residents for purposes of law enforcement, thereby easing the		
14	administrative burden on the enforcement agency and reducing		
15	enforcement gaps that may allow the violator to fail to comply		
16	with the terms of the citation. Reciprocity agreements such as

- 3 The Interstate Wildlife Violator Compact is modeled after
- 4 the successful multistate driver license compact and nonresident
- 5 violator compact. Hawaii is party to both compacts.
- 6 Forty-eight states have passed legislation necessary to
- 7 join the Interstate Wildlife Violator Compact. Existing member
- 8 states to the Interstate Wildlife Violator Compact have reported
- 9 little to no added costs or administrative burdens associated
- 10 with participating in the compact. The information system that
- 11 facilitates participation is available for a nominal annual fee
- 12 (\$500) to member states.
- 13 The purpose of this Act is to authorize the department of
- 14 land and natural resources to enter into the Interstate Wildlife
- 15 Violator Compact or similar agreement for mutual assistance in
- 16 the enforcement of wildlife laws.
- 17 SECTION 2. Chapter 183D, Hawaii Revised Statutes, is
- 18 amended by adding to part I a new section to be appropriately
- 19 designated and to read as follows:
- 20 "§183D- Interstate wildlife violator compact. (a) The
- 21 department may enter into the interstate wildlife violator

1 compact or similar agreement, whether in the form of a 2 memorandum of understanding, written agreement, or mutual aid 3 compact, with an appropriate state, federal, or foreign entity 4 for mutual assistance in the enforcement of hunting, fishing, 5 and other wildlife laws, rules, or regulations in their 6 respective jurisdictions. 7 Employees of the department who perform an act of (b) 8 omission or commission in administering or enforcing the terms 9 or conditions of the agreement entered into pursuant to 10 subsection (a), if the act is within the course and scope of 11 their employment in administering or enforcing the agreement, 12 shall be: 13 Immune from civil liability for damages; (1) 14 Entitled to legal representation for defense of legal (2) 15 actions in which they are a named party or of claims 16 in which they are implicated; and **17** (3) Entitled to indemnification for any damages arising 18 from legal actions or claims resulting therefrom. 19 The department may adopt rules pursuant to chapter 91 20 necessary for enforcement of the agreement entered into pursuant 21 to subsection (a)." 22 SECTION 3. New statutory material is underscored.

TITLE:

A BILL FOR AN ACT RELATING TO THE INTERSTATE

WILDLIFE VIOLATOR COMPACT.

PURPOSE:

To authorize the Department to enter into the Interstate Wildlife Violator Compact or similar agreement for mutual assistance in the enforcement of wildlife laws.

MEANS:

Add a new section to part I of chapter 183D, Hawaii Revised Statutes.

JUSTIFICATION:

The Interstate Wildlife Violator Compact is a multistate agreement that promotes enforcement of hunting, fishing, trapping, and other wildlife related regulations across jurisdictions. For example, the Interstate Wildlife Violator Compact could prevent wildlife violators who have lost their hunting, fishing, trapping, or other wildlife related privileges in other member states from obtaining a hunting license in Hawaii. Similarly, persons who have been punished with license revocation in Hawaii would be unable to avoid this punishment by engaging in those activities in another state. The Interstate Wildlife Violator Compact also establishes a process by which nonresident wildlife law violators can be treated as state residents for purposes of law enforcement, thereby easing the administrative burden on the enforcement agency and reducing enforcement gaps that may allow the violator to fail to comply with the terms of the citation. Reciprocity agreements such as the Interstate Wildlife Violator Compact are an important part of any law enforcement effort.

The Interstate Wildlife Violator Compact is modeled after the successful Multistate Driver License Compact and Nonresident Violator Compact. Hawaii is party to both compacts.

Forty-eight states have passed legislation necessary to join the Interstate Wildlife Violator Compact. Existing member states to the Interstate Wildlife Violator Compact have reported little to no added costs or administrative burdens associated with participating in the compact. The information system that facilitates participation is available for free to member states.

Impact on the public: This bill would enable the Department to join the Interstate Wildlife Violator Compact, preventing persons who have lost their hunting, fishing, or other wildlife privileges from obtaining a hunting license in Hawaii.

Impact on the department and other agencies: There will be little to no added costs or administrative burdens associated with participating in the compact. The information system that facilitates participation is available for a nominal annual fee (\$500) to member states.
