BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to amend the
2	mandatory inscription on civil identification cards by deleting
3	the two words "STATE OF" in front of the words "HAWAII
4	IDENTIFICATION CARD" by amending section 286-305(a), Hawaii
5	Revised Statutes.
6	SECTION 2. Section 286-305, Hawaii Revised Statutes, is
7	amended by amending subsection (a) to read as follows:
8	$^{"}$ (a) Each identification card issued by the examiner of
9	drivers shall display a distinguishing number assigned to the
10	cardholder, and shall display the following inscription:
11	"[STATE OF] HAWAII IDENTIFICATION CARD""
12 13	SECTION 3. Statutory material to be repealed is bracketed
14	and stricken. New statutory material is underscored.
15	SECTION 4. This Act shall take effect upon its approval.

"State of Hawaii Identification Card".

require these holders to come into the

issuing county offices for a corrected card would cause a great deal of inconvenience to the public as well as add to the long lines at the issuing county offices. It is much more expedient and convenient to amend the

law that requires the inscription.
