A BILL FOR AN ACT

RELATING TO HOURS OF WORK.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that offering public
- 2 employees the option of a flexible work schedule through
- 3 staggered work hours will benefit families, communities,
- 4 environment, and economy. Some of the benefits include less
- 5 traffic on the roads during peak commute times, shorter commute
- 6 times, less pollution, more time at home with family, and more
- 7 opportunities to enjoy the island lifestyle.
- 8 The legislature further finds that staggered work hours for
- 9 state employees can result in up to a seventy per cent reduction
- 10 in commute time for all commuters. Staggered work hours results
- 11 in less vehicles on the road during peak traffic times due to
- 12 extended daily work hours plus less total days of driving to
- 13 work downtown or to the University of Hawaii, for example.
- 14 Reducing commute times from all of Hawaii's drivers, will reduce
- 15 stress and may help Hawaii's residents live healthier lives.
- 16 The legislature also notes that offering flexible work
- 17 schedules to state employees can benefit businesses that depend

1	on vehicle travel, such as trucking and delivery companies, as		
2	less traffic on the roads could lead to greater efficiency for		
3	these types of businesses.		
4	The pu	urpose of this Act is to offer public employees the	
5	option to choose a flexible work schedule with staggered work

7	SECTION 2. Chapter 78, Hawaii Revised Statutes, is amende		
8	by adding a new section to be appropriately designated and to		
9	read as follows:		
10	" <u>§78-</u>	Staggered work week; authorized. (a) Beginning	
11	January 1, 2020, the chief executive shall grant each public		
12	employee the option of being available for the transaction of		
13	public business under one of three types of staggered work week		
14	schedules a	as follows:	
15	<u>(1)</u> <u>]</u>	Public employees who shall be available for the	
16	<u> 1</u>	transaction of public business for a five-day, eight	
17	Ī	nours-per-day work week, between the hours of	
18		7:45 a.m. and 4:30 p.m., Monday to Friday, inclusive;	
19	(2)	Public employees who shall be available for the	
20	<u>.</u>	transaction of public business for a four-day, ten	
21	7	nours-per-day work week, between the hours of

1		7:15 a.m. and 6:00 p.m., Monday to Thursday,
2		inclusive; and
3	(3)	Public employees who shall be available for the
4		transaction of public business for a nine-day, eighty-
5		eight hours per two work weeks, inclusive, whose

7		the appointing authority.
8	(b)	Any public employee who does not exercise a choice
9	under sub	section (a) shall be deemed to have exercised the
10	option to	be available for the transaction of public business
11	for a fiv	e-day, eight-hours-a-day work week, between the hours
12	of 7:45 a	.m. and 4:30 p.m., Monday to Friday, inclusive.
13	(c)	No option exercised under this section shall be deemed
14	irrevocab	le; provided that the appointing authority may require
15	an adequate period of notice prior to effecting a change in the	
16	work schedule of the public employee.	
17	(d)	A lunch period of forty-five minutes per day will be
18	allowed a	ll public employees, and shall not constitute working
19	time unde	r this section."
