A BILL FOR AN ACT

RELATING TO THE AGRIBUSINESS DEVELOPMENT CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) The auditor shall conduct a financial
- 2 audit of the agribusiness development corporation established
- 3 pursuant to chapter 163D, Hawaii Revised Statutes. The
- 4 financial audit shall include all agribusiness development
- 5 corporation financial statements from fiscal years ending June
- 6 30, 2019, June 30, 2020, and June 30, 2021.
- 7 (b) The auditor shall submit a report to the legislature
- 8 of findings and recommendations, including any proposed
- 9 legislation, no later than twenty days prior to the convening of
- 10 the regular session of 2022.
- 11 SECTION 2. (a) The department of agriculture shall
- 12 conduct a management audit of the agribusiness development
- 13 corporation established pursuant to chapter 163D, Hawaii Revised
- 14 Statutes. The department of agriculture, pursuant to section
- 15 141-1(3), Hawaii Revised Statutes, may enter into a contract,
- 16 cooperative agreement, or other transaction to effectuate the
- 17 purposes of this Act.



- 1 (b) The chairperson of the board of agriculture shall
- 2 submit a report to the legislature of findings and
- 3 recommendations, including any proposed legislation, no later
- 4 than twenty days prior to the convening of the regular session
- 5 of 2022.
- 6 SECTION 3. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$ or so much
- 8 thereof as may be necessary for fiscal year 2019-2020 and the
- 9 same sum or so much thereof as may be necessary for fiscal year
- 10 2020-2021 for a financial audit of the agribusiness development
- 11 corporation.
- 12 The sums appropriated shall be expended by the auditor for
- 13 the purposes of this Act.
- 14 SECTION 4. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so much
- 16 thereof as may be necessary for fiscal year 2019-2020 and the
- 17 same sum or so much thereof as may be necessary for fiscal year
- 18 2020-2021 for a management audit of the agribusiness development
- 19 corporation.
- The sums appropriated shall be expended by the department
- 21 of agriculture for the purposes of this Act.

1 SECTION 5. This Act shall take effect on July 1, 2050.
