A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that of the four hundred
- 2 thousand people who suffer an out-of-hospital cardiac arrest in
- 3 the United States each year, only six per cent survive the
- 4 episode. In the State, emergency medical services teams treat
- 5 nearly one thousand one hundred cases of out-of-hospital cardiac
- 6 arrest each year, with only nine per cent of these victims
- 7 surviving. Additionally, cities that have increased training
- 8 for cardiopulmonary resuscitation have seen cardiac arrest
- 9 survival rates reach up to sixty per cent.
- 10 The legislature further finds that thirty-nine states and
- 11 the District of Columbia have passed legislation requiring
- 12 cardiopulmonary resuscitation training as a high school
- 13 graduation requirement and at least seventy-five per cent of
- 14 public high school students in the United States that are
- 15 graduating this year will have learned lifesaving
- 16 cardiopulmonary resuscitation in their schools. By
- 17 incorporating cardiopulmonary resuscitation training, which can



- 1 be completed in a single thirty-minute session, as an integral
- 2 part of the health education curriculum for all students in
- 3 grades nine through twelve in the State, there is a less
- 4 likelihood that Hawaii residents will not feel helpless to act
- 5 during a cardiac arrest emergency and survival rates for out-of-
- 6 hospital cardiac arrests will increase.
- 7 The purpose of this Act is to require public, private, and
- 8 charter schools to include instruction in cardiopulmonary
- 9 resuscitation into its health education curriculum for students
- 10 in grades nine through twelve.
- 11 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
- 12 amended by adding a new section to be appropriately designated
- 13 and to read as follows:
- 14 "§302A- Cardiopulmonary resuscitation education. (a)
- 15 Beginning with the 2020-2021 school year, the department shall
- 16 provide instruction in cardiopulmonary resuscitation to high
- 17 school students and such instruction shall be included in at
- 18 least one health education class required for graduation.
- (b) Instruction provided under this section shall:
