A BILL FOR AN ACT

RELATING TO ECONOMIC DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that on November 1, 1972,
- 2 business leaders of Hawaii and Japan met in Honolulu to
- 3 establish the Japan-Hawaii economic council. Their primary
- 4 motivations were to further economic relations between Japan and
- 5 the United States and to recognize Hawaii's important role in
- 6 that regard. For nearly thirty years, hundreds of business and
- 7 government leaders from Japan and Hawaii met at annual meetings,
- 8 alternating between Hawaii and Japan, to discuss and improve
- 9 business, tourism, investment, education, and other mutually
- 10 beneficial interests. These meetings improved relations,
- 11 increased cultural understanding, reduced trade restrictions,
- 12 and improved the economies of Japan and the United States,
- 13 particularly Hawaii.
- 14 The legislature finds that relations between China and
- 15 Hawaii today are similar to those that began to develop between
- 16 Japan and Hawaii in the 1960s and 1970s. The legislature
- 17 further finds that establishment of a similar China-Hawaii

- 1 economic council will provide an invaluable opportunity to
- 2 further economic relations between Hawaii and China, including
- 3 providing a better understanding of cultural differences,
- 4 facilitating investment, increasing tourism, and promoting
- 5 trade.
- 6 The purpose of this Act is to establish the China-Hawaii
- 7 economic council to further economic relations between China and
- 8 Hawaii.
- 9 SECTION 2. Chapter 201, Hawaii Revised Statutes, is
- 10 amended by adding a new section to be appropriately designated
- 11 and to read as follows:
- 12 "§201- China-Hawaii economic council. (a) There is
- 13 established within the department of business, economic
- 14 development, and tourism for administrative purposes the China-
- 15 Hawaii economic council to further economic relations between
- 16 China and Hawaii.
- 17 (b) The China-Hawaii economic council shall be governed by
- 18 a policymaking and oversight commission to be known as the
- 19 China-Hawaii economic council commission. The China-Hawaii
- 20 economic council commission shall consist of seven members
- 21 appointed by the governor as provided in section 26-34. Members

- 14 SECTION 3. The China-Hawaii economic council shall submit
- 15 an annual report to the legislature no later than twenty days
- 16 prior to the convening of the 2022, 2023, and 2024 regular
- 17 sessions, which at a minimum shall include a description of the
- 18 council's progress in conducting the inaugural China-Hawaii
- 19 economic council general meeting.
- 20 SECTION 4. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$ or so much



- 1 thereof as may be necessary for fiscal year 2019-2020 and the
- 2 same sum or so much thereof as may be necessary for fiscal year
- 3 2020-2021 for the China-Hawaii economic council.
- 4 The sums appropriated shall be expended by the department
- 5 of business, economic development, and tourism for the purposes
- 6 of this Act.
- 7 SECTION 5. New statutory material is underscored.
- 8 SECTION 6. This Act shall take effect on July 1, 2019.
