A BILL FOR AN ACT

RELATING TO PET BOARDING FACILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Hawaii Revised Statutes is amended by 2 adding a new chapter to title 11 to be appropriately designated 3 and to read as follows: 4 "CHAPTER 5 PET BOARDING FACILITIES 6 -1 Definitions. As used in this chapter, unless the 7 context requires otherwise:
- 8 "Board" means the board of agriculture.
- 9 "Department" means the department of agriculture.
- 10 "Enclosure" means a permanent or temporary enclosure used
- 11 at a pet boarding facility.
- 12 "Enrichment" means the provision of objects or activities,
- 13 appropriate to the needs of the species, age, size, and
- 14 condition of a pet, that stimulate the pet and promote the pet's
- 15 well-being.
- "Illness" means a disordered, weakened, or unsound 16
- 17 condition.



1 "Injury" means physical pain or impairment of physical 2 condition. 3 "Operator" means a person who owns or operates a pet 4 boarding facility. 5 "Permanent enclosure" means a structure, including an 6 exercise run, kennel, or room, used to restrict a pet, that 7 provides for the safe and effective separation of a pet from the pet's waste products. 8 9 "Person" means an individual, partnership, firm, limited **10** liability company, corporation, association, trust, estate, or 11 other legal entity. 12 "Pet" means any nonhuman animal housed in the pet boarding 13 facility, including any mammal, birds, reptile, or amphibian. 14 "Pet" does not include any horse. "Pet boarding facility": 15 **16** Means any lot, building, structure, enclosure, or 17 premises, or a portion thereof, whereupon four or more 18 pets in any combination are boarded at the request of, 19 and in exchange for consideration provided by, the 20 respective owners of the pets; and

1	(2)	Does not include a county animal control agency;
2		society for the prevention of cruelty to animals;
3		humane society that contracts with a county for the
4		care of stray or abandoned animals; or the premises of
5		a facility under the control of a licensed
6		veterinarian.
7	"Tem	porary enclosure" means a structure used to restrict a
8	pet, incl	uding a crate or cage, that does not provide for the
9	effective	separation of a pet from the pet's waste products.
10	S	-2 Pet board facilities. An operator shall:
11	(1)	Ensure that the entire pet boarding facility,
12		including all equipment therein, is structurally sound
13		and maintained in good repair;
14	(2)	Ensure that pests do not inhabit any part of the pet
15		boarding facility in a number large enough to be
16		harmful, threatening, or annoying to the pets;
17	(3)	Ensure the containment of pets within the pet boarding
18		facility, and, if a pet escapes from the facility,
19		make reasonable efforts to immediately capture the
20		escaped pet;

1	(4)	ir an escaped pet has not been captured despite
2		reasonable efforts, ensure that all material facts
3		regarding the pet's escape are reported to the
4		department and to the owner;
5	(5)	Ensure that the pet boarding facility's interior
6		building surfaces, including walls and floors, are
7		constructed in a manner that permits them to be
8		readily cleaned and sanitized;
9	(6)	Ensure that light is distributed, by natural or
10		artificial means, in a manner that permits routine
11		inspection and cleaning, and the proper care and
12		maintenance of the pets;
13	(7)	If pet grooming services are offered by a pet boarding
14		facility, separate the grooming work area from the pet
15		boarding facility's permanent or fixed and temporary
16		enclosures, and ensure that the grooming areas are
17		cleaned and sanitized at least once daily;
18	(8)	Store food in an area separate from permanent or fixed
19		enclosures or temporary enclosures;

(9) Maintaining an area for isolating pets with illnesses

from healthy pets;

1	(10)	Ensure pets always have access to areas that do not
2		exceed degrees Fahrenheit; and
3	(11)	Comply with this chapter and any administrative rules
4		adopted thereunder.
5	S	-3 Enclosures. (a) An operator shall ensure that
6	each encl	osure:
7	(1)	Is structurally sound and maintained in good repair to
8		protect an enclosed pet from injury, to contain a pet,
9		to keep other animals from straying inside, and to
10		promote the health and well-being of the pet;
11	(2)	Is maintained in a comfortable and sanitary manner;
12	(3)	Is constructed of material suitable for regular
13		cleaning and sanitizing;
14	(4)	Does not contain any pets when the container is being
15		cleaned in a manner or with a substance that may be
16		harmful to a pet;
17	(5)	Houses only one pet at a time, unless otherwise
18		consented to by the respective owner of each pet
19		enclosed;
20	(6)	Provides heating, cooling, lighting, ventilation,
21	•	shade, and protection from the elements, including the

1		sun, wind, and rain, to the extent needed to ensure
2		the comfort and well-being of any enclosed pet; and
3	(7)	Is of sufficient size to allow any enclosed pet to
4		turn around freely, stand easily, and sit or lie down
5		in a comfortable position.
6	(b)	Each permanent enclosure used for a cat shall provide
7	an elevat	ed platform appropriate for the size of the cat or cats
8	in the en	closure.
9	(c)	A pet may be contained in a temporary enclosure for a
10	period no	t to exceed four hours during the day and twelve hours
11	at night	or the length of time that is humane for that
12	particula	r pet, whichever is less. However, the pet shall
13	remain ou	tside the temporary enclosure for no less than the
14	amount of	time needed for the pet to eliminate its waste.
15	S	-4 Pet care. An operator shall:
16	(1)	Observe each pet as necessary, and in no event less
17		than twice every twenty-four hours, to monitor the pet
18		for signs of illness, injury, or distress, and to
19		ensure that the pet, food, waste, or debris are
20		removed from the enclosure as necessary to prevent

contamination or injury;

1	(2)	Provide each pet with easy and convenient access to
2		potable water at all times, or if the behavior of the
3		pet makes unrestricted access to water impracticable,
4		offer water as often as necessary to ensure the pet's
5		health and well-being; provided that water may be
6	•	restricted as directed by the pet's owner or a
7		licensed veterinarian;
8	(3)	Provide each pet with nutritious food in quantities
9		and at intervals suitable for that pet;
10	(4)	Provide each pet with daily enrichment sufficient to
11		maintain the behavioral health of the pet;
12	(5)	Isolate a pet that has or is suspected of having an
13		illness and expeditiously and completely sanitize all
14		areas that the pet inhabited, including indoor and
15		outdoor fecal waste areas;
16	(6)	Ensure that a pet with an illness or injury
17		immediately receives appropriate care and veterinary
18		treatment, as needed;
19	(7)	Ensure that the owner of a pet is notified immediately
20		if the owner's pet has an illness or has an injury,

unless the owner has indicated in writing that

21

1		notification of any, or any particular, type of
2		illness or injury is not required; and
3	(8)	If a natural disaster, an emergency evacuation, or
4		other similar occurrence occurs, ensure the humane
5		care and treatment of each pet to the extent that
6		access to the pet is reasonably available.
7	S	-5 Written information. (a) An operator shall
8	provide t	he owner of a pet that is boarded at the pet boarding
9	facility	with written information describing:
10	(1)	Days and times during which the pet boarding facility
11		allows pets to be dropped off and picked up;
12	(2)	Days and times during which personnel are on site;
13	(3)	The square footage of the permanent or fixed and
14		temporary enclosures in which pets are customarily
15		contained;
16	(4)	Daily observation practices applicable to each species
17		of pet; and
18	(5)	The expected daily activity schedule for the owner's
19		pet.
20	(b)	If the pet boarding facility expects to deviate from
21	the infor	mation provided pursuant to subsection (a) with respec-

- 1 to an owner's pet, the operator shall disclose the deviations to
- 2 the owner, as appropriate.
- 3 § -6 Fire safety. Each operator shall ensure that the
- 4 pet boarding facility has a:
- 5 (1) Fire alarm system that is connected to a central
- 6 reporting station that alerts the local fire
- 7 department in case of fire and a fire escape known to
- 8 all employees; or
- **9** (2) Fire suppression sprinkler system.
- 10 § -7 Enforcement; penalties. (a) The department may
- 11 inspect any pet boarding facility within the State at any time.
- 12 (b) If the department discovers a violation under this
- 13 chapter, the department shall issue to the operator a notice to
- 14 correct the violation.
- 15 (c) The notice to correct shall:
- 16 (1) Be delivered in person by a representative of the
- department to the owner;
- 18 (2) Specify each violation of this chapter;
- 19 (3) Identify the corrective action for the violation or
- violations; and

- (4) Include a specific period of time during which the
 listed violation or violations to be corrected.
- 3 (d) After issuing a notice to correct the department
- 4 within a reasonable period of time, shall conduct an inspection
- 5 of the pet boarding facility to verify compliance with this
- 6 section.
- 7 (e) An operator who is verified to have complied with a
- 8 notice to correct shall not be penalized under subsection
- 9 (h)(1).
- 10 (f) An operator who violates this chapter on more than one
- 11 occasion within a five-year period shall not receive a notice to
- 12 correct for any subsequent violation and shall be subject to
- 13 penalties as provided in this section; provided that this
- 14 subsection shall not apply to multiple initial violations that
- 15 were committed or discovered concurrently.
- 16 (q) An operator that causes or allows harm or injury to an
- 17 animal, or allows an animal to be subject to an unreasonable
- 18 risk of harm or injury, is guilty of a misdemeanor.
- (h) Except as provided in subsections (e) and (g), an
- 20 operator who violates this chapter shall be subject to a civil

- 1 fine not to exceed \$250 for the first violation and a civil fine
- of \$1,000 for each subsequent violation.
- 3 (i) This chapter shall be not construed to supersede,
- 4 limit, or affect the application or enforcement of any other
- 5 law.
- 6 § -8 Enforcement; penalties. The board shall adopt
- 7 rules, pursuant to chapter 91, necessary for the purposes of
- 8 this chapter."
- 9 SECTION 2. This Act shall take effect upon its approval.
