BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 281, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 Reporting of shipments by carriers. (a) "§281-5 Notwithstanding section 281-33, any express carrier company, 6 common or contract carrier, or other person that transports 7 liquor from outside the State for delivery in the State to any 8 person, except those having a class 1 manufacturer license or 9 class 3 wholesale dealer license, shall prepare and file a 10 monthly report with the liquor commission of each county in 11 which the delivery is made. The report shall contain the 12 following information: 13 The known wine, beer, alcohol, or other liquor (1)14 shipments containing the name of the express carrier 15 company, common or contract carrier, or other person 16 making the report;

17 (2) The period of time covered by the report;
